Leech Lake Tribal Court will not modify a custody, parenting time, or child support order issued by another court unless that court has determined that it no longer has jurisdiction; or the parents, acting parents, and child(ren) no longer reside in the state which currently has jurisdiction; or if the parties have agreed that jurisdiction should be transferred from the issuing court to the Leech Lake Tribal Court and the issuing court thereafter relinquishes jurisdiction and transfers the case to Leech Lake Tribal Court.
