    reservation to determine people's level of income, etc. for economic development and resources
    offered through the various offices; potential for help with event planning and longer Duluth office
    hours
  - Whenever we do events we need to try and get everyone to fill out a household form with current/correct/updated information so the office can update their database for check distributions, event notification, etc.
  - We would like to get updated regarding check distribution for December
  - Leech Lake financial services opened a couple of years ago and people still don't know about them and what services they offer; they will attempt to hold an event in Duluth to update community members of what services they offer
  - Coordinate with the LLBO fire department to host a CPR/First Aid training session in Duluth; Laura will contact them about setting this up and getting the information out; She will get the specifics on who can attend; this will most likely be on the weekend for an all-day class

- Pat talked about her trip to Standing Rock with the elders last weekend; They did a good job taking care of the elders by offering good healthy snacks and water; There was an EMT on the bus as well as other EMT's following wherever they went; They went to first camp and were welcomed in with prayer and signing; There were drones flying overhead interrupting their ceremonies; Pat said they were so nice there and got fed by the camp; On the second day they went to Sacred Stone camp; They were told about a dam that was set up to cause flooding in an attempt to force people out the camps; Community member Larry M asked "How do you find out about these trips?" Pat said she was contacted directly by Eva; We suggested he check the website and Facebook for upcoming events
