Federal Court Indictments of Potts and Johnson

The Leech Lake Band of Ojibwe Tribal Council acknowledges with guarded optimism the federal court indictments of Craig Potts and Michael W. Johnson. The Federal Government has charged the pair with various crimes of corruption involving a proposed casino development with the Leech Lake Band.

Leech Lake Band of Ojibwe Tribal Chairman, George Goggleye, Jr., hopes this is just the opening salvo in a fight meant to root out corruption and misapplication of tribal funds, which has previously plagued the Band. Over the last two years, the Band has had the accounting firm of Eide Bailly LLP conduct a thorough forensic examination of the Band's financial activities. The results have not yet been publicly released; however, initial reports indicate that from 2002 until 2004, up to \$10,000,000 in tribal funds was misspent in violation of federal and/or tribal regulations.

Since Goggleye became Chairman of the Band in June of 2004, the Tribal Council has hired their own personal investigator, who has worked with both Eide Bailly and federal investigators to provide key information regarding the Band's financial activities. Goggleye stated, "Our current Tribal Council has worked tirelessly on making up this \$10,000,000 deficit at no small cost to our constituents. As a tribe, we have to rely on the U.S. Attorney's office for prosecution of these types of matters. Therefore, we are emphatically seeking assistance in order to hold individuals accountable for their role in any possible criminal misapplication of tribal funds."

The students of these programs will be building two model homes this fall while attending school.

During the last quarterly Leech Lake Reservation Tribal Council meeting held on July 6, 2007 at the Palace Casino Paradise Room, Chairman George Goggleye, Jr. reported on the following subjects listed below.

Nelson Land Act Settlement -After several years of attempting to come to an agreement with the other Bands that are part of the Minnesota Chippewa Tribe, the saga continues in regards to the Nelson Land Act Settlement. As most of you are aware, both Leech Lake and White Earth lost the majority of their land in this deal.

The Leech Lake Band is entitled to 68.9% of the 20 million dollars that was awarded to the Minnesota Chippewa Tribe. The smaller Minnesota Chippewa Bands, with the exception of White Earth, are lobbying to split the settlement money into six even splits. Congressman Jim Oberstar has also introduced legislation to do a split of 1/6th for all six Bands. If this happens, both Leech Lake and White Earth will lose out again.

Leech Lake has retained a law firm in Washington, D.C., Anderson, Toole, to lobby on behalf of Leech Lake on this particular subject. The firm will work for 40 hours a month toward a settlement to award the monies split according to per capita base. If the firm were successful in their lobbying efforts, this settlement would be in Leech Lake's favor.

Leech Lake Chairman George

Goggleye and other Tribal Council members have met with 9 out of the 10 members of the Minnesota legislation regarding the Nelson Act, and have made it clear to them that a 1/6th split between all Bands is not acceptable to the Leech Lake Band of Ojibwe. The Leech Lake Band of Ojibwe. The Leech Lake Tribal Council will continue with their efforts to ensure that Leech Lake is fairly compensated for damages incurred in this land deal.

Leech Lake Veterans – Governor Tim Pawlenty signed and approved a bill on May 4, 2007 which created eight (8) Tribal Veterans Service Officer positions and one supervisor overall. One of those positions will be at Leech Lake, and seven other positions will be dedicated to other Minnesota Reservations yet to be determined.

Minnesota Indian Affairs Council – A bill has been introduced to restructure the MIAC. Although there has been some opposition to the restructuring concept, work will continue to recognize MIAC as a government.

Housing – Leech Lake has the opportunity to take part in HUD's Home Loan Program. This program would be a separate entity from the current Leech Lake Housing Authority, and would be administered through the Band. "With the increasing demand for housing at Leech Lake, we are left with no other choice, we must address the housing issues for our people" said Chairman Goggleye.

Democratic Ticket

- Chairman Goggleye had the opportunity to meet and talk with famous comedian, Al Franken, at the Palace Casino recently. Franken intends to run against Senator Norm Coleman for a seat in the Senate in the next election. The two discussed school funds and health care funds, among other topics as well. Franken has vowed to work hard on behalf of Leech Lake that our treaty rights are met and upheld if he takes over Coleman's senate seat.

Lastly, Chairman Goggleye, has promised to make sure policy is being followed throughout the Leech Lake Band organization and to hold employees accountable.

One is the Leadership Committee. The members of this Committee are Rita Marcell who is the Coordinator, Spencer Whitefeather, Shirley Nordrum, Suzie Ross, and Mario Reves. This committee is the actual "hands-on" people who will manage the Center. The other group is the Advisory Committee. The members of this Committee are Pat Kvale, Richard Schulman, Delina White, Sharon Kottla, Gary Charwood, and Milt Gotchie. This Committee are the overseers of policies and procedures. Other volunteers are Larry Cronquist, Joseph Gonyer, Ray Pemberton, Donny Harrison, Eva Wilson, Kay Schroeder, Rita Marrall, Duane Losh, and Frank Reese.

Students utilizing the Achievement Center will be taught by volunteers on how to use the computers and their programs, The Blackfeet Nation of Montana was the first reservation that was successful in obtaining an Achievement Center for their Tribe.

Achievement Center users will learn the internet, email, computer fundamentals and MicroSoft Office applications. The Center also includes a genealogy program where users will be able to go back and trace their family trees. Also included is an American Greetings program where people will be able to make their own greeting cards, amongst other programs.

Jack Stevens who is the Chief of the Division of Economic Development with the office of Indian Energy and Economic Development was one of the guest speakers. He said, "This is a celebration today, this is a party!" Stevens was one of those that pushed this dream of the Achievement Center into reality. He went on to say, "This will connect Tribal members with a store house of knowledge, it's going to be like a candy store in there, the software is marvelous!"

Krsitin Fabos, from the SeniorNet offices in California flew in for the Grand Opening event. Fabos commented that SeniorNet is the nation's largest technical trainer and has been around since 1986. She congratulated the Band on their new Center and urged Band seniors and members to use for their benefit and their empowerment.

Leslie Smith, Business Development Executive, with IBM America, told of how three years ago the Native American Chamber of Commerce came to IBM with the idea of creating Achievement Centers for Indian Reservations. Together, they formed a partnership, which also included SeniorNet and the Department of Interior. Out of 361 Tribes applying for an Achievement Center, only 5 Bands were chosen throughout the entire United States. The choice was very difficult for everyone involved. Smith said, "The Achievement Center is now in the

Cass Lake – Bena Schools S.T.A.R. Project

On July 1, 2007, United States Office of Indian Education awarded Cass Lake – Bena Schools a four year Demonstration Grant in the amount of \$882,320.00. This OIEC grant will fund The Cass Lake–Bena High School S.T.A.R. Project - a comprehensive and collaborative project which will prepare the class of 2011 CLBHS American Indian students for successful transition to postsecondary education.

The project purposes include increasing student participation and academic achievement in math, science, and other challenging courses; promoting school engagement; enhancing retention and transition skill development; and assisting students with future goal orientation.

Project components include expanding project-based learning Project Lead the Way® coursework; providing after school tutoring; teacher training in integrating indigenous concepts into rigorous math and science coursework; summer for-credit Leech Lake Tribal College (LLTC) coursework; and participation in quarterly LLTC provided indigenous science seminars tied to CLBHS science curriculum.

The project represents a formal partnership that includes Cass Lake– Bena Schools, Leech Lake Tribal College and the University of Minnesota Institute on Community Integration.

Congressman Peterson & Oberstar To Headline Renewable Energy Conference

State Representative Sailer and State Senator Olson to host August 17 forum on rural economic development at Bemidji State University

The 2007 Legislative Session was a banner one for energy policy in Minnesota with passage of a landmark Renewable Energy Standard and aroundbreaking energy policy. In order to bring greater awareness of the opportunities that recent state and federal legislation present for rural economic development, State Representative Brita Sailer and State Senator Mary Olson will be hosting a daylong Energy Conference at Bemidji State University on August 17, featuring States Congressmen Jim United Oberstar and Collin Peterson.

"Minnesota is in a unique position to lead the nation, in both energy policy and renewable development and production," said Representative Sailer, a member of the House Energy Finance and Policy Division. "We've already played a leading role in the ethanol boom, and we've passed a nation-leading Renewable Energy Standard that sends a strong signal that Minnesota is open for business in the new energy economy. We're in a position to create exciting new opportunities to bring good-paying jobs and industry development to rural Minnesota and the entire region."

The forum will feature prominent players in the move to develop alternative energy sources, including Congressman Collin Peterson, Chair of the U.S. House Agriculture Committee and Congressman Jim Oberstar, Chair of the U.S. House Committee on Transportation and Infrastructure, and Minnesota legislators State Senator David Tomassoni, Chair of the Senate Economic Development Budget Division and State Representative Bill Hilty, Chair of the House Energy Finance and Policy Division. Minnesota renewable energy and economic development experts will include representatives from the University of Minnesota's Initiative for Renewable Energy, the Great Plains Institute, the Rural Renewable Energy Alliance, the Minnesota Department of **EmploymentandEconomicDevelopment** and the Red Lake Tribal Program on bio-fuels, wind and biomass- electrical generation.

"Rural Minnesota stands to reap some rich economic benefits from renewable energy development," said Senator Olson, a member of the Senate Economic Development Budget Division. "We hope the forum will give a good overview for businesses, local governments, schools and the general public to learn about the opportunities that exist because of changes in state and federal policy and the recent advances in renewable technology."

The forum will be held in the Beaux Arts Ballroom on the campus of Bemidji State University on August 17. Registration begins at 9:00AM, with state and federal policy presentations beginning at 9:30AM. After a noon break for lunch and an afternoon session with Minnesota energy and business experts, the conference will conclude with a reception and light refreshments and an informal opportunity to meet with policymakers and others who have been on the ground floor of the emerging renewable energy field. Vendor booths will be open throughout the day.

Elders Can Lead Us In Heart Disease Prevention

Elders are the keepers of knowledge about traditions that strengthen hearts. Traditional foods are often the healthiest foods. Venison, fish, wild rice and blueberries are very healthy foods. Baked, broiled and boiled foods are much better for us than fried.

Our traditional lifestyle involved much physical activity. Walking and running strengthened our hearts. Our elders can tell us about other activities.

We know that soda pop has been terrible for our people, contributing to diabetes, high blood pressure and heart disease. A healthier alternative is to drink the teas that are made from plants where we live. Our elders can teach us which plants to pick and how to make tea.

Elders also know how to prepare foods for feasts and celebrations. This knowledge is passed from generation to generation. Now, as heart disease is the leading cause of death in our communities, we need our elders to help us find healthier ways to prepare those foods.

Elders can be leaders in heart disease prevention by reducing the amounts of saturated fat, cholesterol and salt when cooking traditional foods. This can be done, for example, by cutting the fat off meat before cooking it, skimming the fat off soups and stews, and draining the fat off ground beef. Substitute low-fat dairy products for those that are high in saturated fat or cholesterol. Cook food with small amounts of vegetable oil or margarine, instead of lard or but-

ter. Instead of using salt, elders can add more of the other traditional spices to flavor our traditional foods.

Traditional foods prepared with less animal fat and salt will keep older people healthier. It will also help future generations prepare traditional foods in ways that will strengthen their hearts. Young people will learn to love the taste of food prepared in a healthier way, because they will associate it with the feasts and ceremonies that are special in our lives. And they will remember grandmother preparing it just that way!

Immediate Response

To ensure veterans with mental health crisis have immediate access to trained coordinators, the Department of Veterans Affairs (VA) will establish a 24-hour, national suicide prevention hot line.

"This is another significant step to ensure that veterans, particularly the newest generation of combat vets returning from Iraq and Afghanistan, receive accessible and compassionate care for their mental health concerns," said Secretary of Veterans Affairs Jim Nicholson.

The hot line, which is scheduled to begin operations by August 31, 2007, will be based at the Canandaigua VA Medical Center in New York State. Staffed by mental health professionals, it will operate seven days a week, 24 hours a day.

In addition to staffing the hot line, the suicide prevention coordinators will take part in training clinicians and non-clinicians on warning signs for suicide, guide veterans into care and work within facilities to identify veterans at risk for suicide.

VA's Canandaigua facility is already a VA center of excellence focused on suicide prevention, mental health education and research.

VA has the nation's largest mental health program. The Department recently announced plans to provide suicide prevention coordinators at each of its 153 medical centers, joining more than 9,000 mental health professionals.

Mental health services are provided at each of VA's 153 medical centers and more than 900 outpatient clinics. Last month, Nicholson announced an initiative to hire 100 new employees to provide readjustment counseling at each of the Department's 207 communitybased Vet Centers.

In July, VA will convene a four-day mental health forum in Washington with the Department's

top mental health professionals to review a wide range of issues, such as integrating mental health services with primary care, combat trauma, suicide prevention and the special needs of the newest generation of combat veterans.

Anishinabe Legal Services Receives Funding From the Indian Land Tenure Foundation

The purpose of this funding is to deliver estate planning services to members of Indian Reservations within the White Earth and Leech Lake Reservations.

Services to be provided are: Community Education – Informational sessions on AIPRA (the American Indian Probate Reform Act) – estate planning documents such as Wills, Durable Power of Attorney, Health Care Directive, Standby Custodian Develop materials. Advice and Representation – Discuss options – draft documents such as Wills, Durable Power of Attorney, Health Care Directive, and Standby Custodian.

As a result of Band's internal investigations, the Leech Lake Tribal Council has filed a civil action in state court regarding the "100 Homes" fiasco, the end result of which was the completion of four homes in excess of \$900,000. Additional civil actions are pending.

Swimmer Itch Concern For Area Lakes

Swimmer itch is common during hot summer days in some area lakes. Swimmer itch is characterized by small, irritating red welts that appear after swimming and will produce severe itching. These welts may last from a few hours to a couple of weeks causing discomfort. If you find that you have these symptoms, you may not choose to swim in that particular lake due to the discomfort you will experience. You can avoid infection by vigorously toweling dry immediately after swimming, before water droplets dry on your skin. Application of an oily suntan lotion before entering the water may also help prevent swimmer itch. If welts develop, use calamine lotion to provide relief.

Swimmer itch is caused by a parasitic blood fluke that normally infects water birds and mammals. We are only affected by swimmer itch when stage one in the life cycle of this parasite, the ceraria, burrows into human skin. Cercariae can tell the difference between their usual host and humans; but, when they are trapped in a droplet of water on the surface of the skin and this small pool begins to evaporate, they respond by burrowing in. They are unable to penetrate underlying barriers of human skin and therefore are unable to mature in humans. Therefore, this parasite poses no serious threat to humans.

The life cycle of parasitic blood fluke starts when the parasite lives as an adult in mammals and birds, such as mice and ducks. Then the adult worm sheds its eggs via the host's excretory tract into the water. At this time, they hatch into a freeswimming stage called a miracidium. The miracidium swim in search of a proper second host animal, a particular type of snail. If a proper snail is found, the miracidium will penetrate into the snail's tissue and undergo further development. After a three-or four-week development period, another free-swimming stage called a cercaria emerges from the snail in search of the proper primary bird or mammal host.

Diesel Emissions & Health Effects Meeting Scheduled

The Leech Lake Band of Ojibwe is hosting a workshop on Diesel Emissions and Reducina Health Effects. The workshop will be held at the Minnesota Chippewa Tribe Headquarters in Cass Lake on August 23rd from 8-4:30. Workshop presenters include Minnesota State government officials from the Pollution Control Agency and Department of Health, Clean Air Minnesota Project Green Fleet, Green Range Renewable Energy, and Donaldson Company Inc. Presenters will cover the topics of: general concerns, state regulatory issues and partnerships, funding initiatives, health issues, fuel technologies, and engine technologies. Attendees include school districts and bus contractors, on and off road equipment owner/operators, fleet owner/operators, tribal, county and city officials, and most importantly community members.

Diesel exhaust contains significant levels of small particles, known as fine particulate matter. These fine particles are so small that several thousand of them could fit on the period at the end of this sentence, making them a serious public health concern. These particles can have hundreds of chemicals attached to their surfaces, including many mutagens and/or carcinogens.

Diesel emissions pose a significant health risk because they can pass through the nose and throat and lodge themselves deep in the lungs causing lung irritation, damage, and premature death. Diesel emissions can also aggravate respiratory conditions such as asthma and bronchitis. People with existing heart or lung disease, <u>asthma</u> or other respiratory problems are most sensitive to the health effects of fine particles. Children are more sensitive to air pollution because their lungs are still developing and they breathe at a faster rate than adults. The elderly and those with immune deficiencies are also sensitive to these emissions. Nationwide, particulate matter is responsible for tens of thousands premature deaths every year.

Environmental effects of fine particles from diesel engines contribute to haze, which restricts our ability to see long distances. Diesel exhaust contributes to ozone/ smog formation, acid rain, and global climate change.

The Leech Lake Band Air Quality Program recognizes that education on the effects of and how to reduce diesel emissions influences our daily lives is an effective way to protect local air quality, individual health, and the health of the community. "This is a concern for our rural communities just as much as it is for the Twin Cities," states Brandy Toft Air Quality Specialist with the Leech Lake Band of Ojibwe. "This workshop will empower area diesel engine operators and community members by informing them about the effects of diesel emissions, technologies, and funding efforts; thereby enabling them to make better decisions to keep our air healthy." Chippewa National Forest Looking for Campground Fee Feedback

The Chippewa National Forest is looking for feedback on a proposal to increase camping fees by three dollars at six campgrounds and by two dollars at all other campgrounds on the Chippewa National Forest campgrounds beginning in 2008. Any proposal for camping fee increases will be reviewed by a Recreation Resource Advisory Committee (RRAC), which was recently established to represent all national forests within the Eastern

Region of the Forest Service. The campgrounds proposed for three dollar fee increases:

• Stony Point (Walker area) currently \$20; proposed \$23/night

• O-Ne-Gum-E (Deer River area) currently \$18; proposed \$21/ night

• Norway Beach Complex (Cass Lake area):

• Chippewa Loop currently \$20; proposed \$23/night

• Cass Lake Loop currently \$18; proposed \$21/night

• Norway Beach Loop currently \$18; proposed \$21/night

• Wanaki Loop currently \$18; proposed \$21/night

• All other campgrounds currently are \$14; proposed \$16/ night

Fee increases help reflect more accurate costs of administering and maintaining high quality campgrounds, are comparative to fees at other private and public camping facilities in the area, and allow the Chippewa to continue providing amenities and improve services. These fees are used in the same places where visitors paid them.

The Leech Lake Tribal Council recently addressed an issue concerning severance pay to an elected official eaving office. Secretary-Treasurer requested Archie LaRose had everance pay that he felt he was entitled to when he was removed from office in 2004. Subsequent Council review showed that in three previous nstances under past administrations, an outgoing council member received severance pay when he was removed br resigned before he completed his erm in office. The current council members then acted, in the interests of fairness and equity, and based on precedent, to authorize an equivalent amount, or in LaRose's case, 240 hours pay at his 2004 rate of pay.

Shelly Pemberton

Shelly graduated in 1998 with a AAS Entrepreneurship and is currently the **Business Manager at** the LL Tribal College. Upon graduating

from the LLTC, she continued on to Bemidji State University to obtain her BS degree in Accounting, which she completed in 2004.

"The Tribal College was very supportive to me in achieving this major accomplishment in my life."

Shelly has 2 children and reminds them weekly about how important it is to get their High School Diploma and start College at an early age. "My son gets really annoyed when I joke around with him and tell him he can't have a girlfriend until he is 27, this will give him time to get his schooling out of the way."

Before coming to the Tribal College, Shelly had already tried to go to a University and did not do well. She was not big on the auditorium class size settings and not getting to speak with the instructor on a daily basis. She dropped out and started working. Then, enrolled at the Tribal College, she says.

"The class room size was about 10 and we could all hear one another with out a microphone, we could speak with the instructor openly and freely, whenever a question popped into our head."

"I also enjoyed the pot luck gatherings, which I didn't participate in until late in the semesters. Everyone made you feel like family, asked how they were doing and what things were happening in their lives. Just made you feel comfortable and welcomed. I previously came from a school that had a very small Indian Student count, which only offered a course in Native American art, nothing else in Native American Culture was there for us to choose from. When I

came to the Tribal College, I found it odd that they were requiring me to take Ojibwe language to obtain my AAS degree. I never really knew what a Tribal College stood for and what their mission was until I became a student myself. I am grateful for that opportunity to learn some of our history, language, and ways of our ancestors. I am no expert, but that small amount of Native American Culture I learned, made me truly feel good about myself and my culture."

Shelly would like to some day try and get a master's degree, but states: "The longer I wait the harder it gets to go back, So I will take this time to encourage all individuals not to put off your education. It is too important to our native society."

We asked her if she had any words of encouragement or advice for future grads or current students and this was her response.

"I believe that everyday is a test in life for everyone, some may have it easy, others may have it seldom throughout their lives, and most have it daily. The struggle may be hard but finding yourself, who you are, and who matters in this life, is a great accomplishment. It's a great sense of well being. If education is your way of finding yourself, then commit to it strongly as if it is a job for you. Earlier in the years you may have only needed a BA/BS degree to get a great job, today you need more than that MA/MS or your PHD. You will love the feeling when you accomplish your goal and dream."
