Leech Lake Police Officers Commended

On April 6, 2007, several of the Leech Lake Band of Ojibwe police officers aided in the search of a gunman who had shot a man by the name of William Desjarlait, out on the Old Mission Road near Cass Lake, Mn. They were assisted by the Beltrami County Sheriff's office in the apprehension. Leech Lake police officers quickly developed information leading to the name of the suspect, William Morris.

Later that day, the LLPD officers learned that Morris was in still in the area where the shooting took place, and was possibly in the woods nearby. LLPD Officers Dave Gordon and Sgt. Ken Washington immediately tracked the suspect through the snow and called for back up. Together, the LLPD and the Beltrami County Sheriff's office created a perimeter and K-9 handlers were brought in to aid in the search. After searching through the afternoon, the suspect was apprehended. Also, the pistol that was mostly likely used in the attack was also recovered that afternoon.

Beltrami County Sheriff, Phil Hodapp, said, "In this type of cooperation and team work all of the agencies involved and their officers is such a great example of how law enforcement in this day and age should be conducted. The successful resolution of this case would not have been possible without the hard work of so many

of the Leech Lake officers."

What is the Leech Lake Healthy Heart Project ?

Did you know that the number one killer of American Indian people is cardiovascular disease? The Leech Lake Healthy Heart Project is a program that helps American Indian people with Type II Diabetes learn how to reduce their risk factors for cardiovascular disease (heart attack and stroke). Lowering blood pressure to less than 130/80, exercising regularly, and eating less saturated fat (animal fat) are methods that reduce the risk for cardiovascular disease. More methods to prevent cardiovascular disease are lowering blood cholesterols and smoking cessation.

People who are enrolled in the program are getting healthier. They attend the "Honoring the Gift of Heart Health" classes and learn how to prepare and cook foods that are nutritious. They learn how to read food labels. Participants are exercising at the Diabetes Fitness Center and in their homes. They talk to a case manager, and the program pharmacist. Participants learn about their diabetes and understand why they take medication and what it does for their body. Participants attend educational luncheons and learn healthier ways to live with diabetes.

If you have Type II diabetes, live near Leech Lake Reservation, and are eligible for the IHS public health service, you are eligible to participate in the Leech Lake Healthy Heart project. ORDER TO SHOW CAUSE

YOU (THE DEFENDANTS LISTED BELOW) ARE HEREBY ORDERED to appear before the Leech Lake Tribal Court on **Tuesday, May 29, 2007**, at **2:00 p.m.**, and show cause why you should not be held in Contempt of Court for failure to pay court-ordered fines.

YOU ARE FURTHER NOTIFIED that pursuant to Leech Lake Traffic Code, Chapter, Section 304:

1. If you are found in Contempt of Court, you may be subject to an additional penalty not to exceed \$500.00, said penalty for contempt shall be in addition to any fines or other penalties previously assessed by this Court.

2. You may also be subject to one or more of the following enforcement actions without further notice:

- a. Report violation to the State of Minnesota for entry on defendant's driving record;
- b. Add the fine to the amount defendant must pay to renew or obtain Leech Lake vehicle registration or plates;

Bill Allowing Reunification of Adopted Siblings Gains Preliminary Senate Approval

The Minnesota Senate gave preliminary approval today of legislation allowing siblings separated by adoption or foster care to seek reunification. The Senate's final vote on the bill, Senate File 358, could occur as soon as tomorrow. "Current law allows for the reunification of children with their biological parents following adoptive or foster care, but does not grant the same rights to biological siblings," said Sen. Mary Olson, DFL - Bemidji, chief author of the bill. "My bill corrects this legal oversight."

The legislation allows a person placed in adoptive or foster care to request information from the Department of Human Services or an adoption agency regarding any genetic siblings that also were placed by the system. The bill requires the Department, county agencies, and other placement services to share information that could help determine the location of a separated sibling. The Department would give identifying and contact information to the siblings only if both parties consented.

"This legislation could be life changing for many Minnesotans who may not know whether they have a biological brother or sister," said Sen. Olson. "Adopted citizens sometimes need to find biological relatives for medical or legal reasons. Other times the need to locate a genetic sibling is much more personal. There is no good reason the state should prevent this reunification from occurring." Sen. Olson emphasized that this bill does not apply in situations where one sibling remained with a biological parent. "Nothing in this bill will allow a parent who has given up a child to be located against their wishes," said Sen. Olson.

Letter To the Editor:

Recently, the Senate Judiciary Committee heard legislation that would legalize the use of marijuana for medical purposes. I believe that some news reports have inadequately discussed this issue, and I would appreciate the opportunity to explain why I voted against the bill.

First, I would like to say that if this bill were crafted narrowly enough so I could be comfortable we were making marijuana available only to those with terminal or severe medical conditions who could not be helped with another drug, I would feel differently about my vote. I am very sympathetic to anyone in this situation and to families watching a loved one suffer.

In my opinion, however, the only evidence presented that marijuana has medicinal benefits that can't be replicated by another drug was entirely anecdotal. No mainstream medical organization, such as the American Medical Association, has taken this position. Worse in my mind, the manner in which we will allow this drug to be "dispensed" is almost without control. Anyone who pays \$1,000.00 and registers as a nonprofit (even if that person is a family member of the person using the drug) can grow marijuana plants in their home (or almost anywhere else). Under the proposed bill, there are no regulations regarding the strength of the marijuana grown; if we are going to treat marijuana as a pain medication, I think we must at least regulate it in the same way.

A person who wants to use marijuana under this bill simply has to find a doctor who will authorize its use (including any out-of-state doctors, and we heard testimony that in Oregon two doctors had issued thousands of prescriptions just for "pain"). Unlike the examples listed in the paper, this bill does not just authorize marijuana use for conditions like cancer and epilepsy. Any person who says he/she has suffered from "intractable pain" and has been taking another medication for at least six months (it could be aspirin) qualifies for a card

allowing that person to use marijuana, provided a doctor will prescribe it. Once again, we heard that in Oregon where a similar law exists, over 90 percent of the prescriptions written were simply for "pain" rather than for the severe medical conditions used to justify passage of the law.

None of us can say for sure that this law will be abused, but common sense indicates to me that the potential certainly is there. We heard from numerous law enforcement officers who were adamantly opposed to passage of the bill. We heard that by passing this law, we will significantly undermine law enforcement's ability to enforce existing drug laws and will make their job much harder.

In the last year, I've heard from far too many of our youth (and adults) about the devastation drugs caused in their lives - a destructive path that nearly always began with marijuana use. Considering the dangerous side effects of this drug, its high potential for misuse, and the extremely loose controls in the proposed legislation, I felt compelled to argue strongly against this bill. While it did pass the committee on a close vote, it has not yet come to the floor for a vote by the full Senate. Before it does, I'd be very interested to hear from my constituents who have opinions about his bill, whether pro or con. I've heard the bill may be included in a larger omnibus bill, which will make it harder to vote against because no doubt the bill will contain other legislation important to my voters.

As always, but especially when I am considering a vote on a difficult issue with legitimate arguments that can be made on both sides, I'm very interested to hear what my constituents think. With issues like this, it is not possible to please everyone, but I try to weigh very carefully what I hear from home.

Environmental Assessment for Off-Highway Vehicle Road Travel Open for Comment

The Chippewa National Forest has completed the Environmental Assessment (EA) for the Off-Highway Vehicle Road (OHV) Travel Access Project. The EA is now available for public review and comment. The project area includes all roads within the Chippewa National Forest boundary on federal lands.

Chippewa National Forest proposes to designate those roads on National Forest lands that are to remain open to OHV use. The Environmental Assessment presents a public-involvement-based OHV travel management proposal only for the National Forest. Minnesota DNR proposals and County proposals are addressed by those agencies. The roads were discussed with other land management agencies, including the Minnesota Department of Natural Resources, Beltrami, Cass and Itasca counties, Leech Lake Division of Resource Management and area townships with roads crossing the Forest. In 2006, public meetings held in local communities to discuss

Off-Highway Vehicle Road Travel alternatives were also very well attended.

The Forest Service issued the Travel Management Rule in 2005, requiring each national forest and grassland to identify and designate those roads, trails and areas that are open to motor vehicle use. The Chippewa National Forest Plan addresses OHV management consistent with the Travel Management rule.

Comments for the Environmental Assessment must be received no later than May 18, 2007. An electronic version of the Environmental Assessment is available for viewing and downloading on the Chippewa National Forest website at <http://www.fs.fed.us/r9/forests/chippewa/projects/>.
