LEECH LAKE RESERVATION ORDINANCE NO. 82-4

- Section 1. Except as hereinafter provided, no Indian shall operate, transport, or posses a snowmobile within the boundaries of the leech Lake Reservation unless said snowmobile has been registered according to the provisions of this Ordinance.
- Section 2. Application for registered on re-registered shall be made to the Leech Lake Reservation Department of Natural Resources in such form as the Leech Lake Reservation Business Committee shall prescribe, and shall state the name and address of all owners of said snowmobile and be signed by at least one (1) owner. Upon receipt of said application and the appropriate fee as hereinafter provided, such snowmobile shall be registered and registration number assigned which shall be affixed to the snowmobile in such manner as the Reservation Department of Natural Resources shall prescribe.
- Section 3. The licensing and fees for registration of each snowmobile shall be set by the Reservation Conservation Commission.
- Section 4. Every owner of a snowmobile shall renew his registration in such manner as the Director of the Reservation Department of Natural Resources shall prescribe, upon payment of the dame registration fee as provided in Section 3 hereof.
- Section 5. No registration hereunder shall be required for the following described snowmobiles:
 - a. Snowmobiles owned by the Minnesota Chippewa Tribe or by any of the Bands comprising the Tribe.
 - b. Snowmobiles owned by Indians who do not reside within the boundairies of the Leech Lake Reservation and are temporarily being used within the Reservation and are registered elsewhere.
 - c. Snowmobiles registered by the State of Minnesota, another state, or another Indian Band or Tribe which have not been within the Leech Lake Reservation for more than thirty (30) consecutive days.
- Section 6. The Leech Lake Reservation Director of Natural Resources may issue special permits to out-of-Reservation snowmobiles from a Reservation, State, or County where Tribal members reside and where registration is not required, to operate on the Leech Lake Reservation for limited periods not to exceed thirty (30) days in connection with organized group outings, races, rallies, trail rides, and other promotional events.
- Section 7. No person under the age of eighteen (18) years may register a snowmobile.
- Section 8. Any person, association, or corporation that violates the provisions of this Ordinance shall be guilty of a petty misdemeanor.

* * * * * * *

Section 9. Any person, association or corporation that violates the provisions of this Ordinance shall be guilty of a petty misdemeanor.

WE DO HEREBY CERTIFY that the foregoing Ordinance was duly adopted on the 23rd day of June, 1982, by a vote of 4 for, 0 against, and 0 obstaining, at a special meeting of the Leech Lake Reservation Business Committee, a quorum being present.
