Lisa was able to spend a lot of time with elders on a volcano – Mauna Kea. Lisa took the elders to the steam vents and saw the red steam at the edge of the volcano. Lisa talked about the offerings that people shared including tobacco, leis and fish.
- We are an important group with the Leech Lake community and we need to work to get our representatives to all our meetings. Remember our voting base is large enough that we can control the vote.

h) ICWA Report

- Leech Lake ICWA has three case managers and a large case load of 93 cases with 160 children in seven county metro area
- In the past three months, 23 cases have been closed and families are reunified
- You can get support services from county social workers, like gift cards and bus cards. This is in part for having a great advocate, be very vocal and Ralph the Leech Lake ICWA Lawyer
- Every Monday there is a staffing meeting in how to provide best services
- Collaborate with other reservations with kids who may possibly be enrolled in Leech Lake

- Invite to Hennepin County to goal: work on issues that brought them to child protection in the first place
- If county social workers don't understand ICWA, call to get the Leech Lake ICWA office involved
