Cass Lake Superfund Site Part I: An Historical Account

he St. Regis Corporation operated a wood treatment facility in Cass Lake from 1957 to 1985. The Champion International Corporation ("Champion") assumed responsibility for the Site in 1985. Champion leased portions of the Site to Burlington Northern Railroad in 1988. The International Paper Company assumed responsibility for the Site in July of 2000.

Known chemicals used at the Site included creosote, pentachlorophenol ("PCP"), No. 2 fuel oil, ketone, and a chemical for preserving wood referred to as "CCA" comprised of copper, chromium and arsenic as a salt solution. Dioxins and furans are also chemicals of concern ("COCs") at this Site, originating as contaminants of industrial grade PCP. Additionally, the Band believes that the Site has not adequately been characterized, and other contaminants may be present, including but not limited to PCBs, DDTs, Mercury, Quinolines, and Carbozoles, for which additional work must be done to characterize and determine action levels for cleanup.

On September 21, 1984 EPA placed the St. Regis Paper Company Site (the "Site") on the National priority List ("NPL"). The State of Minnesota Pollution Control Agency ("MPCA") was the responsible government unit ("RGU") for this Site until 1995, when the EPA became the RGU at the request of the Band.

The Site, as originally designated, was comprised of four operable units ("OU"). OU1 was the Treating Facility; OU2 was the Cass Lake City Dump; OU3 was the Extension of the Cass Lake Municipal Water System; and OU4 was the Contaminated Soil Vault. In February 1985, the MPCA and Champion International Corporation ("Champion") signed two Response Orders by Consent under the Minnesota Environmental Response and Liability Act of 1983 ("MERLA") to implement an agreed remedial plan for the Site, one for the Wood Treatment Facility Area and one for the City Dump Pit Area at the former Cass Lake City Dump. These Orders provided for a remedial investigation and feasibility study of the Site; development and implementation of a Response Action Plan to abate or minimize the release of hazardous substances from the Site; and routine monitoring to determine the effectiveness of the response actions.

On March 5, 1986, MPCA issued two Minnesota Enforcement Decision Documents ("MEDDs") for the Site, one for the Wood Treatment Facility Area and one for the City Dump Pit Area. The MEDDs called for: (1) the installation of groundwater

A Brief Update from Secretary Treasurer Michael J. Bongo

Greeting Fellow Leech Lake Band Members: In an effort to keep the Bend members updated on some of the issues and progress I thought it appropriate to provide you with a short interim report.

First and foremost I would like to remind all of the Band Members to make sure that you update your addresses and social security numbers with the Tribal Enrollment office as soon as possible. As many of you are aware and may have heard the Tribal Council has authorized a tax rebate to all Band Members 18 and over with the rebate checks scheduled to be mailed to the Band Members on December 15, 2008. However in order to do so we need your correct mailing address and social security number.

Recently the Tribal Council held a staff meeting of all the government side employees. I strongly urged the Tribal Council to have this staff meeting for a host of what I believed to be very necessary reasons. To my knowledge this has not been done before in the past. Presently we have over 900 employees on the government side alone. The importance of a staff meeting of this nature especially given the size of the staff from my perspective is to ensure that we establish proper lines of communications between the Tribal Council, the administration and the staff. As I stated to the group at the staff meeting in order for the Leech Lake Reservation to be successful we must understand that we are all on the same team and we need everyone on the same page, moving in the same direction at the same time and everyone must be fully aware of precisely

Open enrollment for Medicare prescription drug coverage doesn't begin until November 15, but now is the time to begin comparing plans. Beneficiaries who want to review their current coverage as well as the other options available to them will have access to information and assistance from many sources including:

The enhanced Medicare Drug Plan Finder, available at www.medicare.gov; Toll free information available 24/7 at 1-800-MEDICARE (1-800-633-4227); The annual Medicare & You 2009 handbook that explains Medicare coverage, to be mailed in October; and Local organizations like the Minnesota Senior LinkAge Line can be contacted to offer personalized assistance with your Medicare Part D questions. The Senior LinkAge Line can be reached at 1-800-333-2433 or their Website at www.minnesotahelp.info.

In Minnesota, beneficiaries will have access to 48 Prescription Drug Plans (PDP's). 27 of those plans have \$0 deductibles and 2 have premiums under \$25. The national average monthly premium for the basic Medicare drug benefit in 2009 is projected to average approximately \$28.

The Senior LinkAge Line is here to help, but they can't help if you don't contact them. Call today to get help over the phone or even set up an in person meeting with a trained specialist who can help explain the plans that might be right for you.

# Snow Removal and Plowing

This year, snowplowing will be coordinated between LL Housing and Department of Public Work's twenty (20) plows. Coordination should get the overall plowing done sooner and cheaper by having plow drivers work in certain areas or zones, plowing for both Departments' clients throughout the Reservation.

Tribal members will be asked to sign a liability waiver for any property damage in advance of any snow plowing. To avoid property damage tribal members should prepare their yards for snow plowing now, by clearing the parts of the yard to be plowed or where snow is piled.

Tribal members who do not want to have their driveways plowed should call Department of Public Works (DPW) to have their name taken off the snowplowing list. DPW Director Bob Goggleye may be reached at 335-8333 or 8334.

If tribal elders or disabled members need help with clearing and preparing their yards, arrangements should be made with the Temporary Employment Program (TEP) at 218-335-3555 or toll free: 888-922-7477, Monday thru Friday. TEP may be contacted for snow shoveling and, depending on the situation, snow removal from roofs.

Anyone not on the snowplowing list or in need of snow shoveling should contact their District Representatives at 335-8200 to have their names added to the lists.

pump-out wells with granular activated carbon treatment which would pump and treat contaminated groundwater until acceptable levels are reached; (2) construction of a Resource Conversation and Recovery Act ("RCRA") on-site containment vault for the deposition of hazardous waste sludge and contaminated soil excavated during removal; (3) extension of the Cass Lake Community Water System to residents not serviced and potentially affected by groundwater contamination from the Site; (4) long term monitoring of the groundwater and surface water to determine the effectiveness of the groundwater pump-out system; (5) long term monitoring of the on-site contaminant vault; (6) long term monitoring of the treated groundwater discharge and selected fish species to determine the effectiveness of the groundwater treatment system; (7) long term operation and maintenance of the groundwater pump-out system; and (8) long term operation and maintenance of the on-site containment vault.

The response goals and objectives, as stated in the MEDD were to:

- 1) adequately protect the public against exposure to PCP, polynuclear aromatic hydrocarbons ("PAHs"), hexa hepta and octachlorodibenzo-p-dioxin ("PCDD") and polychlorinated dibenzo-p-furans ("PCDF") isomers through direct contact or ingestion of groundwater from private and public water supplies.
- 2) adequately protect the public against exposure to PCP, PAH, PCDD and PCDF isomers potentially released to surface water from the groundwater.
- 3) adequately protect and minimize damage to the environment from the migration of PAH, PCDD and PCDF isomers in the groundwater.

See Minnesota Enforcement Decision Document, issued for St. Regis Paper Company, Minnesota Pollution Control Agency, p. 10, March 5, 1986.

Construction of the remedial components of the selected remedy occurred between 1985 and 1987. Groundwater monitoring and vault operation and maintenance have been carried out since June 1987.

In 1995, the MPCA issued a Level 1 Five Year Site Review (First Review). The First Review was based upon a review of all documents associated with the removal action, a Site visit, and a limited ecological risk evaluation. On April 6, 1995, EPA approved the MPCA Five-Year Site Report. The First Review made a number of recommendations for further investigation at the Site, including further analysis of dioxin/furans in fish and sediments, and further monitoring to fully characterize Site groundwater contamination. It also concluded that the ground water RA would remain protective with the implementation of new ARARs (which have not been implemented); and that the RA protectiveness for soils could not be determined because concentrations of contaminants in the soils were unknown.

On January 24, 1995 EPA issued a Unilateral Administrative Order (the "106 Order") under Section 106 of CERCLA, 42 U.S.C. Section 9601 et seq to Champion. The 106 Order, among other things, required Champion to continue to perform certain remedial activities originally undertaken pursuant to the two February 26, 1985 MEDDS issued by the MPCA under MERLA to abate an imminent and substantial endangerment to the public health or welfare or the environment. At that time, oversight authority changed from state-lead to Federal-lead, at the request of the Band.

In the 106 Order, EPA also re-defined the operable units at the Site as follows: OU1 or the "Wood Treatment Facility Area" was defined as the portion of the Site known as the Wood Treatment Facility Area; OU2 or the "Containment Vault Area" was defined as the portion of the Site known as the Contaminated Soil Containment Vault Area; and OU3 or the "City Dump Area" was defined as the portion of the Site bordered to the north by the Wood Treatment Facility Area, to the east by Pike Bay, to the south by Fox Creek, and to the west by the Containment Vault Area. The Band and EPA entered into a support agency cooperative agreement ("SACA") for the Site in 1995.

To date, three Five-Year Reviews of the Site have been completed. The First Review, was completed by the state of Minnesota in 1995 and the last two Five-Year

# **Indians NOT Taxed**

We have always wondered what these simple words mean in the United States Constitution. The Band has been working on delivering a one-time \$200.00 rebate to Tribal members over the age of 18 as part of a 2008 Leech Lake Stimulus package. The Band receives a variety of state dollars related to hunting and fishing as well as State taxation.

At first, Leech Lake was looking to use the Hunting and Fishing dollars

for a rebate, but those dollars would likely be considered "income" for purposes of MFIP, win-win for Leech TANF, Food stamps as well as social security, Lake Tribal Memas well as Federal income tax. Moreover, it appears that if Hunting and Fishing dollars were used, the Leech Lake rebate would displace State and County dollars for one month and those Tribal members using those types of programs would not get the benefit or the full benefit of the Leech Lake Rebate.

After further investigation it has been determined that the Band will use State tax rebate dollars for the \$200.00 payment. By using tax rebate funds, Tribal members using MFIP, TANF or Social Security should be able to avoid any income consequences. This is because the 2008 Leech Lake Rebate will be using taxes collected from Leech Lake Reservation members in 2007. That means the money was earned last year, and taxes and reporting of the income also occurred last year.

This one time \$200.00 rebate is not income because it really is a return of Tribal members' prior payment of sales taxes. It is kind of like finding \$200.00 in your winter coat from last year. It feels like you "earned" more money, but it really was earned last year.

The Legal Department has been working with Minnesota's Department of Human Services and Revenue to obtain a legal opinion that the \$200.00 Tax Rebate is just that, a tax rebate and not new, reportable income. The RBC hopes that the local counties will not at-

> tempt to penalize Leech Lake's members for the one-time, tax rebate.

> This will also help the local counties because the total amount of the tax rebate is about \$1.5 Million, which would be much more meaningful if Counties would accept that the tax rebate is not income. This would be a win-win for Leech Lake Tribal Members and local counties because the \$1.5M would then truly be stimulus of new money into our region.

> A notice from the Legal Department will accom-

pany the \$200.00 rebate when mailed out as checks so Tribal members will understand how the money should only be considered as a tax rebate, not new

Anishinabe Legal Services (ALS) recently hired Paul Day to serve as their new Executive Director. "My goal is to provide our clients with top notch legal services," said Day, "and to develop and maintain stable funding sources." Mr. Day has around 30 Years experience as an attorney and he also served as a Tribal Court Judge for the Mille Lacs Band of Ojibwe. Paul received his degree in law from the University of Minnesota School of Law in 1978.

Anishinabe Legal Services provides free civil court legal information and representation to low-income American Indians who live on the Leech Lake, White Earth, and Red Lake Indian Reservations. ALS is not a tribal entity, but an independent not for profit that secures its funding through grants. They also do not represent clients in criminal court matters. ALS provides free legal services and community education, and is governed by a Board of Directors consisting of attorneys and community members. Their funding comes from various sources including the Legal Services Corporation and the State of Minnesota in addition to grant funding. The types of cases Anishinabe Legal Services handles include but are not limited to: Tribal Court matters, domestic abuse issues, problems with BIA, Indian Health Service, Tribal housing authorities, and other Indian agencies, racial discrimination, Indian jurisdictional issues, civil rights violations, education rights, consumer problems, SSI and other public benefits, Tribal employment and the Indian Child Welfare Act. Priorities sometimes given to cases that involve both Indian law and poverty law and have the potential of helping a large number of eligible clients.

# Leech Lake Government Side Empolyee Meeting at Northern Lights

On November 12 the Leech Lake Tribal Council held an employee meeting at Northern Lights Casino in Walker, with more than 700 people in attendance. The reason for the meeting was to open and strengthen the lines of communication. The Tribal Council opened the lines of communication more so than even before with its employees through some very encouraging words and a few insights on efficiency, community, and accountability as an organization.

Chairman LaRose moderated the meeting saying the goal for the meeting was to make the operations more efficient through better communications with its employees. "The RBC is committed to better serving its band membership".

Executive Director Rob Aitken touched on recent activities and goals both short and long term in nature. Recently, the Tribal Council concluded a trip to the Capital where they met with the State Attorney General Lori Swanson and a few State Legislators. "Building regional and state partnerships with businesses and local regional officials could go a long way in terms of creating more economic opportunities for the band and its membership." Mr. Aitken went on to highlight some of the goals the leadership has put front and center. One of these is a proposed power line that will cross the reservation along the Highway 2 corridor. Leech Lake is going to sit down with Roger Moe on behalf of MN Power, Ottertail Power, and Minnkota Power companies to negotiate a power line that would link power grids from eastern Minnesota to western power grids a result from the 2004 blackouts and a subsequent federal directive for power companies to link the Minnesota grid system. Mr. Aitken closed with some comments about how the system at Leech Lake could be more efficient mentioning the utilization of the chain of command regarding office personnel policies.

Dostrict I Representative Robbie Howe spoke next regarding several issues concerning her district and problems reservation wide. She highlighted alcohol and substance abuse among the youth on the reservation as being a huge concern. "Don't just ignore people's problems until the worst case scenario comes true, we have lost a lot of our young people due to this abuse." Robbie spoke with passion about getting families involved in the healing process as the beginning of dealing with these sorts of issues.

Representative Howe also mentioned that she would like to see another bring a child to work day here at Leech Lake. She mentioned that we need to pay attention to our kids and that they need our support and guidance.

Lyman Losh, the District II Representative from Leech Lake talked about his tenure at Leech Lake, and how the need for things like this employee meeting need to be a regular occurrence. "Communication is the key to a functional Tribal Government" Said the District II Representative.

Eugene "Ribs" Whitebird, the Leech Lake District III Representative thanked the Day Labor crew for doing such a good job, and he thanked everyone for supporting John Percell, on his recent election win regarding the Minnesota House 4A seat. Mr. Whitebird mentioned that the Council is setting up meetings with the Cass County Commissioners, and that the Band is working to get its FCC license to get a radio station online here at Leech Lake.

Communication was absolutely the theme for the meeting and it was nice to see the Tribal Council and Executive staff take the lead with this unprecedented meeting between the employees and our leaders. It was said during the meeting that this had never happened before on the Leech Lake reservation. A meeting purely to open a dialogue and to invite questions and comments on the state of affairs on the rez and in the offices here is something that could bring things into light that might never be heard otherwise. "This is vital to our direction and efficiency. Our biggest goal is to improve the social and economic conditions for our band members. We can only achieve these goals if we work together as a people and an organization.

We work for the people, our band members, and I think we forget this from time to time," said Secretary Treasurer Mike Bongo. Mr. Bongo went on to highlight issues concerning efficiency and taking the initiative. "We all make mistakes myself included, I hope with the best intentions, but sometimes taking chances is good, don't be afraid to take the initiative. I cherish those who do something that needs to be done rather than asking someone if they should do it." Mr. Bongo stated that a Treaty Compensation payment would be goal of theirs for the upcoming holiday season.

Improving youth services is a priority for the Secretary Treasurer. "Summer youth employment is something the band needs again." He stated more recreational activities with the most positive and productive things possible for our kids is essential. "We need to institute a policy where our youth take a career inventory test to match their interests up with possible summer youth employment, under the restriction of having a 'C' average in school." The Secretary Treasurer went on to mention to the employees that being solution oriented should be the mindset when someone comes to them with a problem. "When someone has a problem, help them, rather than just shuffle them along." As the chief financial officer for the Tribe Mr. Bongo mentioned that there has been some minor shifts in some budgets in order to progress in the direction that the leadership would like to go for future endeavors. "We need to be fiscally solvent and strong as an organization. We would like to do things like build new community centers in our local communities." He went on to restate something Executive Director Rob Aitken mentioned about how economic partnerships would aid the Band greatly in achieving this goal.

Before the employee meeting closed the Chairman took the stage to address the audience. He told us about when he was involved in boxing when he was a kid growing up in Cass Lake. Chairman LaRose mentioned that he used to travel around Minnesota from Band to Band and represent Leech Lake as a boxer. "I traveled around a lot to other Bands, when I was younger, and saw how economically and socially poor they were compared to Leech Lake. This is no longer the case. We need to change our ways and work habits as a people and individuals. We need to communicate with each other in order to live with and love each other."



## Leech Lake Tribal Police

The Leech Lake Tribal Police Department is pleased to announce that it is the recipient of the 2008-2009 BIA Highway Safety Officer Grant Program. This is a one-year grant initiative program that is designed to support intense enforcement of Tribal and State Laws regarding traffic safety on the Leech Lake Reservation.

As part of the guidelines for the grant, the Leech Lake Tribal Police Department will be participating in the three National Mobilizations:

- "Dont Shatter the Dream" Impaired Driver Mobilization from December 21st, 2008 to January 3rd, 2009
- "Click it or Ticket", May 2009
- "Drunk Driving, Over the Limit, Under Arrest", August 2009

Following these mobilizations, there will be a written narrative outlining the project highlights to be published as a Public Service Announcement.

In a collaborative effort, the Leech Lake Tribal Police Department and the Leech Lake Health Division have begun an initiative called, "Every Child Deserves a Safe Ride". This initiative will require intense enforcement by the Tribal Police Department to enforce violations of unrestrained children riding in motor vehicles. As part of the initiative for those who are willing, the Leech Lake Health Division and the Leech Lake Tribal Court will work together to divert violators from the court system to partcipate in a class on child safety restraints and their proper use.

Many adults are misinformed regarding the child restraint law. Any officer who observes a child, under the age of four, riding in a motor vehicle, unrestrained, or unbuckled may stop that motor vehicle for violating the child restraint law. Officers observing this violation are making it a priority to stop and cite drivers found in violation of this law.

Review was performed by EPA in 2000 and 2005. The Second Review, conducted after EPA resumed control over the remedial activities at the Site, included sampling and data assessment to fill data gaps identified by the first Five Year Review. EPA's sampling and data assessment activities indicate the presence of dioxins that exceeded EPA action levels and have resulted in several unilateral Administrative Orders for soil removal and Residential Dust Reduction.

An Additional Unilateral Administrative Order resulted in a Draft Human Health and ecological risk assessment sent out for review in December 2005. Agency partners have been reviewing and working through significant deviation in data collection, method analysis and exposure scenarios and calculations. All Partners hope to resolve these outstanding issues by the end of May 2007 and allow International Paper to prepare a second draft based on agencies comments and recommendations.

what the goals, objectives and priorities of the Reservation are. This is of vital importance if we are to be successful in advancing the Leech Lake Reservation both socially and economically.

Other messages of importance that I also believe needed to be communicated to the staff Reservation wide included; the need to encourage staff to take initiative and to be more solution orientated by helping Band Members find and gain the necessary services they are seeking and in need of as opposed to shuffling problems and issues to someone else; to remind and reinforce to the staff of the Leech Lake Reservation to always treat our Band Members and customers with the utmost professionalism and courtesy; to encourage the staff to take pride in their work and in the fact that they work for the people of the Leech Lake Reservation; and finally rekindle a sense of pride, honor and unity in the staff that will hopefully inspire a greater spirit of teamwork amongst the staff.

In late August I was appointed by the Tribal Council to serve as the Tribal Council's representative to Indian Health Service and the Hospital. As the Tribal Council representative I recently served on the Indian Health Service Interviewing and Screening committee to hire a new CEO for the Cass Lake Indian Health Service Hospital. At this time I am pleased to report to the people of the Leech Lake Reservation that as a result of this work we have selected and recommended the hiring of a new Hospital CEO to the Indian Health Service Federal Administration. While I can not share the individual's name with you presently since Indian Health Services has yet to make a formal public announcement, I can share with you that the individual selected is an American Indian from the local area and I believe possesses a comprehensive understanding of the past problems and issues surrounding the hospital.

As a result I believe that as the new CEO this individual will work very closely with the Leech Lake Tribal Council and the people of Leech Lake to improve the quality of care at the hospital and improve the level of customer service as well. Once a formal announcement is

made by Indian Health Service I will be recommending to the Tribal Council that we host a public reception to give the community the opportunity to meet and greet the new Hospital CEO.

A couple of final points of information regarding Indian Health Services, Doris Jones, Leech Lake Health Division Director and I will also be serving on the Hospital's Executive Management Team representing the Leech Lake Reservation. Finally I have also been designated by the Tribal Council to serve on the Hospital's Budget team and during the first week of December I will be traveling to Rockville, Maryland with local Indian Health Service officials in an attempt to negotiate a new budget for the hospital.

Upon my return I will attempt to update the Band's membership as to the future progress of these on-going efforts.

I view all of these initiatives as a positive first step in the right direction. If we are to make the necessary positive changes to ensure quality health care we must have continued open communications and dialog, and above all else we must work together for the common good of our people and community. Finally we must follow up and follow through from start to finish. I point this out because the progress we have made to date is a result of the public meeting to address the hospital issue held back in August of this year.

Presently I am recommending the Tribal Council host a one day Elders Conference at Northern Lights Casino tentatively scheduled for Monday, December 29, 2008 from 9:00 a.m. to 3:00 p.m. with lunch provided. The purpose of this minione day Elders Conference is to seek the guidance and input of our elders in determining what elder services they would like to see provided by the Leech Lake Reservation and how they would like to have these services delivered. We often talk about the value and wisdom of our elders, but all too often we listen but sadly more times than not we fail to hear. The reason that I am promoting the December date is if necessary I am hoping that we can utilize some of the school buses at the Bug School to provide transportation reservation wide for those elders in need of transportation. I am hoping that we can formulate our plans quickly and that we can begin to get notices out to our elders as soon as possible.

I would like to also take this opportunity to commend Doris Jones, Health Division Director and the Health Division staff for their recent successful efforts in securing over \$875,000 in new health grants for the Leech Lake Reservation. Please join me in congratulating Doris and the Health Division staff on a job well done.

Equally as well I would also like to take this opportunity to commend and congratulate Garr Pemberton, Chief of Police and the officers and staff of the Leech Lake Reservation Police Department for their recent successful efforts in securing two new U.S. Department of Justice grants total over \$750,000. Again I would ask the Band membership to please join me in congratulating Chief Pemberton and the officers and staff of the Leech Lake Reservation Police Department on a job well done.

In closing I would ask our Band membership to exercise a little patience and understanding. As a tribe we have many, many pressing priorities, problems and issues. These problems and issues did not just happen overnight. They are the result of many, many years of tribal government living financially for today while failing to plan financially for the future. If as a tribe we are to truly correct these deficiencies it is going to require tightening our collective belts, being smarter, wiser and more prudent in how we do business and in how we manage the collective affairs of the tribe. However the result of these efforts will be the successful, positive long term financial health and future of our people and our Reservation.

#### LEECH LAKE BAND OF OJIBWE TRIBAL HEALTH DIVISION TRANSPORTATION POLICY

#### COMMUNITY HEALTH REPRESENTATIVE TRANSPORTATION POLICY

The community Health Representative Program (CHR) provide services such as light house keeping, vital monitoring, personal care, just to name a few of the services for clients referred to us by the Leech Lake Nursing Program.

The CHR Program does provide medical transportation for the following priority clientele:

Priority clientele are as follows:

- 1. Elders
- 2. Diabetic/Dialysis
- 3. Chemo/Cancer patients
- 4. Heart and Handicap
- 5. Remaining population

In order to receive transportation from the program specific information is needed from the client:

- 1. Client full name
- 2. Appointment date and time
- 3. Client date of birth
- 4. Phone or message number for client
- 5. Complete physical address
- 6. Name of hospital or clinic
- 7. Doctors name and contact number

Two weeks notice is needed for all transports. We network with the staff at I.H.S., surrounding county agencies, L.L. Tribal referral and other tribal entities, social service programs, medical personnel within medical facilities. Clients who are eligible for MA/MC through their county social services program will be required to utilize those services first.

The CHR Program will provide transportation services found not eligible for services from the county. Priority clientele will be given preference over the remaining population.

For patients under the age of eighteen (18) years, they must be accompanied by a parent or legal guardian. A parent or legal guardian must provide car seats for infants and toddlers.

Those excluded from transportation services, which is defined by GSA Fleet Management:

- 1. Those needing a ride to and from a treatment facility.
- 2. Those who are currently incarcerated.
- 3. Those who have an active warrant for arrest in any one of the surrounding counties of the reservation
  - 4. Those who appear to be under the influence of drugs and alcohol, as de fined under the "Reasonable Suspicion" in the LLBO GAPP.
  - 5. Those clients receiving services from a methadone treatment program.

Medication deliveries/pick-up:

1. CHR's will provide this service for elder, heart, cancer, and diabetic as requested by our Leech Lake Nursing staff.

Exclusion: No pain meds will be handled by the CHR staff, no exceptions.


