

## KOJB 90.1 FM is looking forward to going "on the air" this Spring

Cass Lake - KOJB FM 90.1 is coming soon. Work continues on the 500 ft tower in Bena which will send the radio signal to the entire Leech Lake Reservation. The Studio/Office building has arrived (located next to the Leech Lake Tribal College) and structural work is now completed with work continuing on the interior. Next, electronic equipment including audio control boards, transmitter and broadcast antenna will be installed over the next several months. The website KOJB.org should be up soon, but for now KOJB can be found on Facebook-search for KOJB radio.

The Bena communications tower is set to be finished by mid February followed by the conclusion of the transmitter building located next to the tower. The transmitter building weighs 22 tons, is made of solid concrete, and can with-

#### RACINO No Big Jackpot for MN, MIGA says

Racinos at Canterbury Park and Running Aces Harness Track offer no jackpot for Minnesota, says MIGA Executive Director John McCarthy in an opinion commentary published in the Bemidji Pioneer.

McCarthy accused racino advocates of using "bogus arguments and inflated claims" to mislead Minnesotans about the supposed benefits of the racino proposals. He was responding to a previously published commentary by John Derus, a former elected official currently employed by the Running Aces Harness Track to promote its racino effort. Here's what McCarthy wrote:

"The February 11 column by John Derus, a paid advocate for the racino, presents bogus arguments and inflated claims about the benefits of racinos at the state's two racetracks. What Derus doesn't talk about in his column is the high cost of this proposal to Indian tribes, rural economies and ultimately, the state itself.

"Racino proponents claim that their proposal to add slots to racetracks will generate \$125 million a year for the state. What they don't tell Minnesotans is that this amount represents less than two-tenths of one percent of the state's \$6.2 billion deficit. That isn't even a drop in the bucket; it's a drop in the ocean.

#### LLTC Student Named A NASA Ambassador

For the second consecutive year, a Leech Lake Tribal College student has been selected as a student ambassador for the National Aeronautics and Space Administration (NASA).

Terra Greenleaf, a second-year student at LLTC majoring in Liberal Education with a STEM (science, technology, engineering and math) emphasis, was recognized as one of NASA's high-performing interns. She will have the opportunity to represent NASA at a variety of educational and outreach events to help inspire future students interested in STEM careers. Terra is the only student from a Minnesota college or university to receive this honor in 2011.

Terra's internship consisted of three weeks in Bismarck, ND, where she learned to use GIS mapping software and Landsat satellite technology, fol-

lowed by seven weeks of work with the Leech Lake Heritage Sites program using the software to map and record burial sites to protect them from future development.

Terra credits LLTC's science faculty with instilling in her the self-confidence to take on a challenging internship away from home. The daughter of former LLTC president Dr. Leah Carpenter, Terra believes that her level of familiarity with the college was also a big help. "[LLTC] is almost like my second home," she says. "The college and I kind of grew up together."

After completing her degree at Leech Lake Tribal College, Terra plans to attend the University of Washington to pursue a double major in Environmental Science and Political Science, with a minor in American Indian Studies.

#### Special Election results in removal of Secretary Treasurer Michael Bongo

In a vote of 971-384, members of the Leech Lake Band of Ojibwe answered a resounding "yes" Tuesday to the ballot question, "Shall the secretary/treasurer be removed from office?"

Twelve of the 13 precincts voted to remove Secretary/Treasurer Michael Bongo. Only the Sugar Point precinct was against doing so, voting 24-15 to retain him.

"In some respects (the results) were somewhat disappointing," Bongo said in a telephone interview today. "But not unexpected."

Chairman Arthur "Archie" LaRose said Bongo has seven days to appeal the election results, which were certified Wednesday February 9th. If there is no appeal, or the appeal fails, LaRose said the Leech Lake Tribal Council would call a special election to fill the position until the term ends in 2014.

Meanwhile, he said, District I Representative Robbie Howe has agreed to fulfill the secretary/treasurer's duties. The Tribal Council will hold a special meeting at the end of the seven-day appeal process to discuss and vote on her appointment.

Bongo said today that he would not appeal the election results.

"I did my best, put my best foot forward and tried to do what I thought was the best for the band as a whole," he said.

The issue behind the removal/recall petition relates to Bongo's Sept. 14 approval, under his single signature, of a \$2.4 million loan to Bill and Kathy Bieloh and Moondance Jam, Inc. Tribal law requires financial transfers to have the approval of the Tribal Council and the signatures of both the secretary-treasurer and chairman.

According to an investigation by Minneapolis attorney David Lillehaug, Bongo signed the loan agreement for a term of seven years at a rate of 8 percent interest. The loan was to be paid off in annual installments of \$460,973.76 beginning Sept. 14, 2011. Bongo approved the loan on his signature alone without Tribal Council approval, and the bank transferred the funds to the Bielohs.

Security for the loan was real estate and a life insurance policy of \$1 million on Bill Bieloh. However, Bieloh only took out \$500,000 in life insurance at the time of the loan. Bill Bieloh died Sept. 24 of a massive heart attack.

Lillehaug's report was presented to the Leech Lake Band membership Nov. 22. The report concludes, "We are forced to conclude that Bongo knowingly – not just negligently – violated Band law and policies."

LaRose was philosophical about the situation. "Life goes forward," he said in a telephone interview Wednesday. "Moves on, and that's what we've got to do."

#### Tribes form Education Nation Consortium

The culmination of the two-day Education Summit, held in Red Lake on January 19th & 20th, was a signing ceremony in which the three Tribal agreement.

The signing ceremony began about noon and celebrated a new Educational Agreement between Red Lake, Leech Lake, and White Earth Tribes. The agreement is a compact, a pledge for the three nations to cooperate and work together on educational improvements in such crucial areas as Ojibwe language preservation, Indian education improvements, grant partnering and advocacy efforts. The three Tribal Chairs, Floyd Jourdain, Jr. of Red Lake, Arthur "Archie" LaRose of Leech Lake spoke and signed the compact. Erma Vizenor of White Earth was unable to attend and will sign the compact at a later time.

The signing ceremony included the signatures of the three tribal college

presidents (Dan King Red Lake Nation College, Ginny Carney Leech Lake Tribal College and Wannetta Bennet White Earth Tribal College) on the Chairs signed a special education Educational Agreement, and the three Education Directors/Superintendents of schools. Only Red Lake's superintendent Gish was able to attend.

> Summary of the Education Nation Consortium Resolution between Red Lake, Leech Lake & White **Earth Tribal Nations**

Signed on Thursday, January 20, 2011

WHEREAS, the three Tribes of Red Lake, Leech Lake and White Earth have historically close ties; and since we are all members of the Great Ojibwe Nation; and all share the same Ojibwe language and culture; and have recently worked together on economic development and social issues; and have similar educational challenges; and each have Tribal Colleges to serve their respective Tribal Communities;

BE IT RESOLVED, during the educational summit, the Red Lake Band of Chippewa Indians, the Leech Lake Band of Oiibwe, and the White Earth Band of Ojibwe agree to cooperate, share ideas and work together on making educational improvements to the following major issues affecting Indian education:

The crucial and urgent issue of Ojibwe language preservation; and any and all issues affecting Indian education specific program improvements; and mutually agreed upon educational grant partnering and grant endorsements from this new three-Tribe educational consortium; and mutually beneficial advocacy efforts that will help the Tribes of this new consortium;

and since all of the Tribes of this new consortium also have tribal colleges to serve their respective tribal communities, the Tribal College Presidents will also work together on all of these areas that can be of mutual benefit to all members of this consortium, and

BE IT FURTHER RESOLVED, the three Tribal leaders and the three Tribal College Presidents will all sign this historic Education Nation consortium agreement, and

BE IT FURTHER RESOLVED, the three Tribal Education Directors/ Superintendents, if any, of the three respective K-12 Tribal school systems for Tribal Members, will also work together on all of these areas that can be of mutual benefit to all Members of this consortium, and also sign this historic Education Nation consortium agreement, and

BE IT FINALLY RESOLVED, the three Tribes will together create a new charter of operations to establish a process for adding new members, voting, and also sign this new document.

#### New VA Office Bridges Gap Between VA And Tribal Veterans

The Department of Veterans Affairs (VA) felt a new office was needed to bridge the gap between the VA and tribal veterans. The new Office of Tribal Government Relations will serve the approximately 200,000 veterans the VA considers tribal, including: Native Alaskans; Native Hawaiians; and American Indians.

Tribal veterans have a lengthy and notable history of service in this country's military. Their honorable service entitles them to the full spectrum of benefits available through the VA, and the VA's mission is to take care of this nation's soldiers, including even hard to reach veterans.

The American government recog-

nizes 800 different tribal governments, which means 800 different agendas to accommodate. This is the mission of the Office of Tribal Government Relations. Tribal veterans have long since received VA benefits, but the VA hopes to not only strengthen existing relationships with tribal veterans, but develop and build new ones.

Many Native Alaskan veterans living in rural areas have real problems utilizing their earned benefits. Despite having earned them, accessing health care and other benefits can prove to be almost impossible for those veterans living a significant distance from major cities, especially in Alaska. The need for the Office of Tribal Govern-

She was preceded in death by her parents, one special daughter Jessica, brothers; Duane Hanks, Darold Hanks, and Patrick





#### Governor Dayton meets with Tribal Leaders

A Tribal Leader and Governor Summit was held Feb. 9 at the Minnesota State Capitol. Gov. Mark Dayton hosted the meeting attended by members of the Minnesota Indian Affairs Council, including Shakopee Mdewakanton Sioux Community Chairman Stanley R. Crooks.

Pursuant to Minnesota State Law (3.922) a Tribal Leader and Governor Summit was held February 9, 2011, at the Minnesota State Capitol. Governor Mark Dayton hosted the meeting attended by members of the Minnesota Indian Affairs Council, including Shakopee Mdewakanton Sioux Community Chairman Stanley R. Crooks.



Each tribal leader had an opportunity to raise an issue of importance to their tribe at the meeting which lasted more than one hour following the State of the State address. Some of the issues discussed were the Indian Child Welfare Act, education, public safety and corrections, gaming, economic development, language revitalization and Legacy Funding, and nuclear waste storage. Chairman Kevin Leecy (Bois Forte Band of Chippewa) facilitated the meeting as the Chairman of the Minnesota Indian Affairs Council.

Future meetings were discussed and invitations graciously offered by both the tribes and the Governor.

Minnesota State Law (3.922), which describes the Indian Affairs Council duties and responsibilities, one of which is the "annual summit of elected tribal leaders, legislative leaders, and the governor," was enacted in 1963.

Also in attendance were Chairwoman Karen Diver (Fond du Lac Band of Lake Superior Chippewa), Chairwoman Erma Vizenor (White Earth Band of Chippewa Indians), President Victoria Winfrey (Prairie Island Indian Community), Chief Executive Marge Anderson (Mille



Lacs Band of Ojibwe), Chairman Kevin Leecy (Bois Forte Band of Chippewa), Chairman Norman Deschampe (Grand Portage Band of Chippewa Indians), Chairman Archie LaRose (Leech Lake Band of Ojibwe), Chairman Gabe Prescott (Lower Sioux Indian Community), and Chairman Kevin Jensvold (Upper Sioux Community). Chairman Floyd "Buck" Jourdain (Red Lake Band of Chippewa Indians) was unable to attend.

Established in 1963, the Minnesota Indian Affairs Council is the oldest council in the nation and serves as a liaison between the Indian tribes and the state of Minnesota. The MIAC offices, located in St. Paul

and Bemidji, Minnesota, carry out the mission of the Indian Affairs Council, which is "to protect the sovereignty of the eleven Minnesota tribes and ensure the well being of all American Indian citizens throughout the state of Minnesota." The Council provides a forum for and advises state government on issues of concern to urban Indian communities. The Council administers three programs designed to enhance economic opportunities and protect cultural resources for the state's American Indian constituencies.

The MIAC plays a central role in the development of state legislation. They monitor programs that affect the state's American Indian population and tribal governments. Minnesota was the first state in the nation to establish an Indian Affairs agency and provided a model for other states to follow. The Indian Affairs Board is made up of the 11 Tribal Chairs or their designees, a member of the Governor's official staff, the Commissioner of Education, Human Services, Natural Resources, Human Rights, Employment and Economic Development, Corrections, Minnesota Housing Finance Agency, Iron Range resource and rehabilitations, Health, Transportation, Veterans Affairs, and Administration, or their designees.

The Indian Affairs Council's vision is to strive for the social, economic and political justice for all American Indian people living in the State of Minnesota, while embracing traditional cultural and spiritual values.

stand 150 mph winds. It will house KOJB electrical equipment, MIS hardware, and two-way radio infrastructure.

Upon completion of the tower, the 75 foot FM antenna which takes ninety days to be manufactured, will be installed on the top of the tower and tested for a period of two weeks after which the station will be ready for a soft opening in the spring with a grand opening to be scheduled for this summer.

Programming will include: a reservation morning show, a mix of national and local Native American public affairs programming and a variety Native and other music.

The educational mission of KOJB FM will be to enhance the history, language, and life way of the Anishinabe people as well as airing of other national native media and noncommercial programming. KOJB FM will provide media access for adult education, K-12 and higher education by working closely with students and faculty of the Leech Lake Tribal College. A goal of KOJB FM is to help establish communication courses at the Leech Lake Tribal College using KOJB FM as the teaching tool.

The Leech Lake Band of Ojibwe has pledged to operate KOJB FM to provide a non-profit and non-commercial broadcast service in accordance with Section 73.503 of the FCC rules.

Programming for KOJB FM will include Leech Lake current events, Minnesota Chippewa Tribe current events, voices from the Tribal Elders, youth radio locally produced programs, locally produced programs from the tribally run Bug-o-nay-gee-shig (K-12) school, music from Native Artists, and sporting events and powwows from on or near the Leech Lake Reservation.

"They also fail to mention that slot machine revenues have fallen far short of projections in most states, including Colorado, Connecticut, Illinois, Indiana, Maryland, and Montana. Those states are now scrambling to plug the budget holes left by these shortfalls. Gambling is an unreliable source of budgeted revenue.

"Predictably, Derus hauled out the old "level playing field" chestnut. Whenever tribes have had something of value, the dominant society has destroyed or seized it in the name of "leveling the playing field." Here we go again. Tribes have barely had an opportunity to get in the game, and others are looking to change the rules of the playing field and undo their progress.

"Derus claims that the state would get "100 percent of the new gaming tax." That's very deceptive. In fact, the racino is likely to be taxed at a rate of 30 to 50 percent, depending on the proposal. The remaining 50 to 70 percent of revenue will go to the wealthy investors that own the two tracks. In the case of Running Aces, those shareholders don't even live in Minnesota.

"In contrast, tribal casinos are taxed at a rate of 100 percent, meaning that all casino revenues go to tribal governments to pay for housing, human services, health care, education, water and sanitation, law enforcement, courts, tribal administration and infrastructure. Those investments in community benefit all of Minnesota, and not just a group of out-of-state investors.

"As far as regulation, tribal casinos are infinitely more regulated than Minnesota's racetrack industry or the state lottery. Congress made tribes the primary regulators of their own gaming operations, but they are also regulated by Congress, the Department of the Interior, the National Indian Gaming Commission and the State of Minnesota under the compacts.

"The claim that slots at the track will create "thousands of new jobs" across the state is patently false. In fact, the opposite is true. Slots at Running Aces or Canterbury will merely shift jobs from rural Minnesota to the metro area.

"A racino at Running Aces Harness track, for example, could cut revenues at Mille Lacs Band facilities up to 40 percent, potentially leading to the loss of as many as 1200 jobs in rural Minnesota. A track at Canterbury Park would force Mystic Lake to lay off at least 30 percent of its workforce, possibly more. Even if every laid off employee were hired by the track, we're still looking at no net job gain for Minnesota.

"In addition to cutting jobs, tribal casinos affected by racino competition also would be forced to reduce their spending on goods and services, costing Minnesota tribal vendors as much as \$200 million a year.

"It's unfortunate that racino proponents are not giving Minnesotans the full story. Racinos will not solve our budget problems, create new jobs or generate new economic activity. They'll only shift jobs and divert income from rural Minnesota to the metro area. That's not a jackpot. It's a hijacking."







## Important information about the \$3.4 billion Indian Trust Settlement

#### For current or former IIM account holders, Owners of land held in trust or restricted status, or their heirs

There is a proposed Settlement in *Cobell v. Salazar*, a class action lawsuit about individual Indian land held in trust by the federal government. This notice is just a summary. For details, call the toll-free number or visit the website listed below.

The lawsuit claims that the federal government violated its duties by (a) mismanaging trust funds/assets, (b) improperly accounting for those funds, and (c) mismanaging trust land/assets. The trust funds include money collected from farming and grazing leases, timber sales, mining, and oil and gas production from land owned by American Indians/Alaska Natives.

If you are included in the Settlement, your rights will be affected. To object to the Settlement, to comment on it, or to exclude yourself, you should get a detailed notice at <a href="https://www.IndianTrust.com">www.IndianTrust.com</a> or by calling 1-800-961-6109.

#### Can I get money?

There are two groups or "Classes" in the Settlement eligible for payment. Each Class includes individual IIM account holders or owners of land held in trust or restricted status who were alive on September 30, 2009.

#### Historical Accounting Class Members

- Had an open individual Indian Money account ("IIM") anytime between October 25, 1994 and September 30, 2009, and
- The account had at least one cash transaction.
- Includes estates of account holders who died as of September 30, 2009, if the IIM account was still open on that date.

#### Trust Administration Class Members

- Had an IIM account recorded in currently available data in federal government systems any time from approximately 1985 to September 30, 2009, **or**
- Owned trust land or land in restricted status as of September 30, 2009.
- Includes estates of landowners who died as of September 30, 2009 where the trust interests were in probate as of that date. This means you have asked a court to transfer ownership of the deceased landowner's property.

An individual may be included in one or both Classes.

#### What does the Settlement provide?

- A \$1.5 billion fund to pay those included in the Classes.
- A \$1.9 billion fund to buy small interests in trust or restricted land owned by many people.
- Up to \$60 million to fund scholarships to improve access to higher education for Indian youth.
- A government commitment to reform the Indian trust management and accounting system.

#### How much can I get?

- Historical Accounting Class Members will each get \$1,000.
- Trust Administration Class Members will get at least \$500.
- If you own a small parcel of land with many other people, the federal government
  may ask you to sell it. You will be offered fair market value. If you sell your
  land it will be returned to tribal control.

If you believe you are a member of either Class and are not receiving IIM account statements, you will need to call the toll-free number or visit the website to register.

#### What are my other rights?

- If you wish to keep your right to sue the federal government about the claims in this Settlement, you must exclude yourself by **April 20, 2011**.
- If you stay in the Settlement you can object to or comment on it by **April 20**, **2011**. The detailed notice explains how to exclude yourself or object/comment.

The U.S. District Court for the District of Columbia will hold a hearing on June 20, 2011, to consider whether to approve the Settlement. It will also consider a request for attorneys' fees, costs, and expenses in the amount of \$99.9 million. However, Class Counsel has fee agreements that would pay them 14.75% of the funds created for the Classes, which could result in an award of \$223 million. The Court may award more or less than these amounts based on controlling law. If approved, these payments and related costs will come out of the Settlement funds available for payment to Class Members.

# TEAM GROWS

After several months of meetings and briefings, all of which are focused toward maximizing the infrastructure and resources of the Leech Lake Band, the Leech Lake Green Team has made several strides with educating and enacting a more environmentally conscious work environment here at Leech Lake. A resolution crafted by the Green Team was passed by the RBC to ban styrofoam, the Team has received rebate monies for changing the lighting at the facility center, and have also received a grant to initiate composting efforts.

Recently, before a meeting at the Che We shopping complex, a walk through the building with Air Quality Specialist Brandy Toft and Ken Johnson, Energy Management Representative, from Otter Tail Power exposed several ways in which components of the structure could be changed to enhance energy efficiency.

This was the fifth meeting in two weeks regarding the Che We shopping complex where the Green Team and the Planning Department met with organizations and entities that could aid in the effort to maximize resources and curb costs around Leech Lake and specifically at Che We. Everything from the HVAC, lighting, more efficient doors, product coolers, insulation, and light sensors were pointed to as just the "beginning" of what could be done to the building to make it not only more environmentally friendly, but could help save the Band thousands of dollars in heating and electricity costs now and into in the future.

Two grants to initiate composting efforts and education are in the process stages of being awarded to the Green Team. Participating entities within LLBO are the Tribal College, The Palace Casino, Division of Resource Management, Solid Waste and the Bug-O-Nay-Ge-Shig school. Composting efforts will culminate in tens of thousands of dollars saved in tipping fees (fees that the Solid Waste department or the department where garbage is generated pays to dispose garbage) and will also result in saving approximately 62 metric tons of greenhouse gas emissions.
