# Tribal College Partners with Band for Training

The Leech Lake Tribal College agreed to provide carpentry fundamentals customized training modules for 40 hours over the course of two weeks for not more than ten students from LL Facility Maintenance. This agreement provides the Leech Lake Band of Ojibwe with up to 80 total hours of training.

The Leech Lake Band of Ojibwe promises to pay LLTC for the training in no less than two weeks before training starts. This fee includes indirect costs, coordinating services, assessments creation and implementation, and instruction for not more than ten students. This fee does not include tools for each student, books, or lab materials which the Facilities Department will supply themselves.

Our elder population is growing fast and their needs are growing too: I want to expand our current efforts of transportation so every one of our elders can get to the facility that offers the services they require, while at the same time bringing these services to the communities that are the farthest away like Kego Lake, Inger, S Lake, Onigum, Minneapolis, Winnie Dam, and Sugar Point to name just a few.

Our casinos are nice to have but we need to create other means of income as we look to the longer term future: I want to partner with businesses that will invest in Leech Lake and bring manufacturing here as well as light technical and industrial operations that will offer our Band members new opportunities.



### Health Care Demonstration Project

Dr. Donald Warne MD visited and took a tour of Leech Lake facilities earlier this month. Dr. Warne is the Director of the Office of Native American Health located at Sanford Health in South Dakota. He serves as the Senior Policy Advisor to the Great Plains Tribal Chairman's Health Board. Dr. Warne is also an adjunct clinical professor at Arizona State University Sandra Day O'Connor College of Law where he teaches American Indian Health Policy.

His visit began with a breakfast meeting with key staff from a variety of Leech Lake's health care departments. "The visit was brief but important for Leech Lake in that Sanford Health could help Cass Lake IHS in a number of ways if a partnership evolves," said Roger Aitken. Aitken a former Executive Director is helping the effort at Leech Lake regarding the demonstration project has been working on the project since last winter.

Dr. Warne toured several of the Band's health and human services programs and discussed issues with the staff including: Diabetes Health Care Clinic, Opiate Health Center, Health and Fitness Center. Additionally a tour of the hospital facilities was taken as well as conversations with key staff during the tour. This was a huge step in establishing better communications with Sandford Health in key areas of patient data and follow up, both with IHS and Tribal patient issues. It was agreed that regular follow up meetings between the two agencies will strengthen and improve patient services.

Aitken also stated that: The month of May has consisted of site visits, IHS at Cass Lake appears ready to assist Leech Lake financially in an early strategic planning sessions for the HCDP (Health Care Demonstration Proj-

ect). Cass Lake IHS CEO Ms. Noreen Smith has participated in tentative discussions regarding plans to conduct three separate planning sessions, one for each Leech Lake District later this summer. IHS of Cass Lake will finance a large portion of the planning sessions with community members and invited guests. These sessions will be primarily for Leech Lake constituents and organizational staff to provide their input into an improved and innovative new health care model here at Leech Lake. The strategic planning sessions will be facilitated by an outside consultant firm hired by IHS to gather data from these meetings and organize the information into useful data for use in developing funding documents.

We have also made some important steps in developing schematic design drawings of what potential new health facilities Leech Lake may be working toward in the demonstration project with an interested architect and engineering firm. The schematic drawings will give us a visual of what something could look like regarding future devel-

opment. Tentative plans to bring the A&E firm to Leech Lake is mid June 2011 but may be delayed a week or so since a number of Leech Lake personnel will be attending the NCAI convention later in the month.

Hopefully the Health Resources Service Administration (HRSA) will have its rules and policies in place for its three year health center planning grants it announced later this last winter. Tribes will compete for three year planning grants for building health centers in a variety of optional uses by the communities.

Efforts will continue to move the overall HCDP forward in hopes of preparing data for a Program Justifica-

tion Document (PJD) soon to submit to IHS consisting of a set of potential new building and programmatic improvement ideas for congressional funding.

### DRM Green Team Receives Funding

The Minnesota Pollution Control Agency (MPCA) and Indian Health Service (HIS) helped fund the Leech Lake Green Team's efforts to create composting sites around Leech Lake.

The Minnesota Pollution Control Agency monies will go toward the construction of several composting sites at certain locations around the Reservation such as the Tribal College, Palace Casino and Hotel, the Bug-O-Nay-Ge-Shig School, Leech Lake Tribal College, and a demonstration project at Cass Lake Solid Waste. Indian Health Service monies will go toward outreach and education regarding composting. This aspect will cover the why's and how's of composting as well as cover how much money composting can save Leech Lake in tipping fees e.g. over \$30,000.00 in a single year at the Palace Casino and Hotel.

This summer there will be community education classes on composting at the Leech Lake Tribal College with possible discounts on hardware. There will be outreach coming soon to places that have the capacity to compost products as well as hardware that will be located at the Tribal College and Bug-O-Nay-Ge-Shig school.



### **Public Service Announcement**

May was Foster Care Awareness month; we would like to inform our potential foster care parents on the process and goals of the Leech Lake Child Welfare Foster Care Program. The Leech Lake Child Welfare Foster Care Program helps provide healthy, safe, and stable environment for children in the foster care system. The agency goal is to keep children with their families, instead of putting them with non-relatives. We work to reunify children with their parents and families. We currently have 40 foster care home categories ranging from Regular, Therapeutic, Emergency, and Relative. We also process temporary license for families who have relatives in foster care.

In order to receive a foster care license of any category, you will need to stop in our office and complete the intake process. You will be asked to complete background checks on anyone in the home 13 years of age or older, Finger Prints for anyone 18 years of age or older, Urine Analysis on anyone 18 years of age or older, physicals on anyone 18 years of age or older, application packet, and you will have 90 days to complete the process.

### Start A Vegetable Garden

With the increase of food costs it may be time to start a garden. Now may be the time even if you have never grown anything before. All to save money and serve healthier foods!

Vegetable gardens can be easy. You don't need a large space and it just takes a few vegetable plants to begin to save money at the grocery store. What you need is Seeds or Plants, Sunlight, Water and Good Soil. Start out small with a few vegetables either planted outside in the ground or in a planter or flower pot. There are just some basics steps you need to follow.

How much space do you have and what will you be able to manage? Planters or larger flower pots are a great way to grow vegetables if limited with space and time. It involves less planning and you can move the planters around to get the plants in the best growing conditions.

Raised beds allow for a healthy garden plot anywhere. Make your own raised bed from stones or untreated lumber. Raised beds are great if you have poor soil and limited space. They are a good garden choice if you do not enjoy leaning over a garden or have a bad back. Use good soil and so there will be fewer weeds. You can add one raised bed or several to a larger garden space.

If outdoor space is limited, you can actually grow vegetables indoors. And the growing season can be year round! So, basically, this is indoor container gardening. Vegetable Plants that grow well in:

Windowsill Gardens:

- Carrots
- Cress
- Lettuce
- Mustard
- Radishes
- SpinachTomatoes
- Zucchini

Balcony Gardens:

- Beans
- Broccoli
- Brussel Sprouts
- Cabbage
- Cucumbers

Tomatoes

- PeppersPotatoes
- Squash
- Beets
  - Carrots
    - Celery,
    - Chinese Cabbage

Indoors w/Grow Lights:

- Cucumbers
- Spinach
- Onions
- RadishesWatercress

Plants already started are definitely easier and takes less work. Follow the planting directions on the tag. Seeds are cheaper but take more time to get started. Some seeds do well just planted in the garden, like carrots. Or start your seeds inside the house. You can begin by starting seeds in toilet paper rolls with a little soil. Water them and remember to keep everything labeled to know what is planted. The seedlings you start from seeds cannot go right in the ground. They will need to be put outside in sunlight, a little longer each day when the weather is warmer, late May or early June. After they have "hardened up" this way, you can plant them in the ground.

Walk through the garden every few days and inspect for bugs and weeds. Do you need a fence or another pest control product for rabbits or deer? Don't get frustrated. When all your tomatoes start coming in and saving on the grocery bill, you will see its worth. Just a few vegetable plants can save a lot of money! Start easy and small! It's about growing your own food and reducing the grocery bill. And it is good physical activity!

### **TEP Implementing New Program**

The TEP Program has accomplished a lot this year, one of the new jobs coming on line is the "Watercraft Inspector" program that provides inspections of watercraft and trailers at public accesses for Aquatic Invasive Species (AIS). The goal is to reduce the spread of invasive species into and around the state.

To accomplish this we need to complete at least 800 hours of watercraft inspections this year, which has been fundraised through private donations from the residents of Big Man Trap Lake Association. Lyle Laske and Judy Hanson had found what is the best option and the Board of Directors has voted to hire the Leech Lake Band of Ojibwe TEP Program. "It seems really fitting the Leech Lake Band will be helping us keep our Lakes free of invasive species as their ancestors were, after all, the first residents on Big Man Trap Lake," said Hanson.

We (TEP Director Janice Gale and Watercraft Inspectors: Roger Burnette, Will Davis, Mary Jones, Cheyenne Lussier, Charles Lussier, TEP Office Staff) will be meeting with the Big Man Trap Lake Association on Saturday June 11, 2011 at 9:30 am to visit and answer any questions from the association.



#### FINDINGS, CONCLUSIONS AND FINAL ORDER FOR CONTEMPT OF COURT

A review of the Court records revealed that the defendants listed below were properly served with notice of Findings, Conclusions and Stayed Order for Contempt of Court via United States mail and/or publication in two (2) consecutive issues of the DeBahJiMon. The defendants failed to purge the Contempt of Court. Based on all the files, records and proceedings herein, the Court makes the following:

#### FINDINGS:

- 1. That each of the defendants listed below were found in contempt of court and a civil contempt penalty was stayed on condition that defendants purge the contempt of court by paying all outstanding fines or signing a repayment agreement.
- 2. That defendants were properly served with a copy of the Order for Contempt pursuant to Leech Lake Judicial Code, Title II, Rule 5.C.
- That the defendants were given ample time to request that the contempt order be set aside or make arrangements to pay the fine.
- That the defendants failed to make arrangements to pay the fine or request that the contempt order be set aside.

#### CONCLUSIONS OF LAW:

The defendants listed below are guilty of Contempt of Court for failure to make arrangements to pay fines as ordered by the Leech Lake Tribal Court, pursuant to Section 303 of the Leech Lake Traffic Code.

#### WHEREFORE IT IS HEREBY ORDERED:

- 1. The stay of the civil contempt penalty in the amount show below is hereby lifted. Defendants are ordered to pay the fine totals shown below (original fine plus civil contempt penalty not to exceed \$500.00).
- Pursuant to the Leech Lake Traffic Code, Section 304.E, defendants' total fines as shown below will be added to the amount he/she must pay to renew or obtain Leech Lake vehicle registration or plates.
- A copy of this Order shall be provided to the Leech Lake Department of Motor Vehicles, which shall add the total fine due to the amount defendant is required to pay to renew or obtain Leech Lake vehicle registration or plates.
- 4. If defendants are unable to pay the total amount due to obtain/renew license plates, he/ she may sign a payment agreement with the Tribal Court. An Order will then be issued authorizing the Leech Lake Department of Motor Vehicles to allow the defendant to register/obtain vehicle registration or plates.
- Failure to comply with the payment agreement will result in an Order, pursuant to Leech Lake Traffic Code, Section 304.A and 304.C, for seizure and impoundment of the license plates and/or the vehicle driven at the time of the offense. The defendants' license plates and/or vehicle will be returned upon payment in full of the unpaid balance of the fine.
- If the defendants fail to execute a repayment agreement pursuant to paragraph four (4) above, the Leech Lake Band is hereby authorized to commence garnishment proceedings to collect the fine pursuant to Leech Lake Traffic Code, Section 303.D.


