## **Capital Hill and the White House During Impact Week in D.C.**

Newly re-elected Congressman Rick Nolan is new on the political scene, again. As some of you may know, Congressman Rick Nolan previously served as the U.S. Representative for Minnesota's 6th congressional district from 1975 to 1981. After returning to the political stage in 2011 he was nominated and then challenged Republican incumbent Chip Cravaak in the 8th District defeating Cravaack soundly last November. After his victory last fall, he has settled in and is ready to go, and it was our pleasure to meet with him during our visit. The Leech Lake delegation's meeting was very interesting indeed. The Congressman was energetic, eager, and chomping at the bit to get the ball rolling for Minnesota's 8<sup>th</sup> district, and for Leech Lake.

During our meeting, tribal roads director Art Chase discussed the new federal formula for funding tribal roads: MAP-21 (Moving Ahead Progress for the 21st Century Act) was signed into law in 2012 and was a point of interest during the meeting with Mr. Nolan. Consequently the new formula reduced the amount of funding for Leech Lake dramatically. The new formula that cut millions from Leech Lake's roads budget takes Band population more into account as opposed to the old formula which took number of miles of roads in a Tribe's inventory into account. This new version of the formula benefits large member bands and cuts funding from bands with greater numbers of roads i.e., tribes in the Midwest with larger highway infrastructure.

As the meeting progressed we mentioned our greater land management goals, how we could help get the MAP-21 formula readjusted for roads funding, what we could do to move the Bug O Nay Ge Shig School up the replacement list at the BIA, and how we could help coordinate inviting Assistant Secretary for Indian Affairs Kevin Washburn to the school for a site visit.

Urgent Need to Replace High School Facility at Bug O Nay Ge Shig School The Bug O Nay Ge Shig School (School) is located in Bena, Minnesota, the building should be replaced. ## **Chairwoman Carri Jones Statement to House Interior Appropriations Subcommittee**

February 27, 2013

y name is Carri Jones, and I am the Chairwoman of the Leech Lake Band of Ojibwe (Band). Our Band is located on the Leech Lake Reservation in northern Minnesota. Chairman Simpson, Ranking Member Moran, and Members of the Subcommittee, I want to thank you for holding this important oversight hearing to examine the significant unmet educational needs of Indian children. I would like to especially thank Representative McCollum for her tireless efforts to assist our students. We are deeply grateful for her support.

My testimony is focused on the Band's long struggle to replace the Bug O Nay Ge Shig School High School (High School) facility, which is administered and funded by the Bureau of Indian Affairs' (BIA) Bureau of Indian Education (BIE).

The High School is in dire and longstanding need of replacement. The High

School facility is a metal-clad pole barn, and its original purpose was to house an automechanic school/bus garage. When the building was transformed into the High School, the intention was that it would only be a temporary fix. However, generations of Band students have suffered for decades in this makeshift building. The facility has serious structural and mechanical deficiencies and lacks proper insulation. The facility does not meet basic safety, fire, and security standards due to the flimsiness of the construction materials, electrical problems, and lack of alarm systems. Further, the building lacks a communication intercom system, telecommunication technology, and safe zones, which puts students, teachers, and staff at great risk in emergency situations. The police and emergency responders have dubbed the high school building as "Killer Hall" because an emergency would likely have tragic results. In addition, in high wind situations over 40 mph, the students must evacuate outside into the winds because of the structural flaws with the flat metal building. Recently the concrete in front of the High School's front doors buckled from the cold weather and blocked the doors. Had there been an emergency situation, as has often occurred in this building, our students would have been trapped.

The High School facility is a constant threat to the health of our students and faculty due to poor indoor air quality that contains mold, fungus, and a faulty HVAC system. The facility also suffers from rodent and bat infestation, roof leaks and sagging roofs, holes in the roofs from ice, uneven floors, poor lighting, sewer problems, lack of handicap access, and lack of classroom and other space. These are just a few of the facility's numerous deficiencies. Due to the unsafe and undesirable condition of the High School, many students leave after middle school to attend the public high school. Students are embarrassed about the condition of the High School, resulting in a negative image of the School in the community and a lower matriculation rate.

The High School is on the BIA's list of schools in need of replacement and has exceeded its life expectancy by decades. The BIA categorizes the high school facility as being in "poor" condition. The BIA Midwest Regional Office for the Office of Indian Education Programs compiled a report in 2007, expressing strong concerns about the electrical problems, potential fire issues, and student safety. The BIA Office of Facilities, Environmental, Safety, and Cultural Management had documented the numerous and serious deficiencies of the High School.

The BIA fully acknowledges the deplorable conditions at the High School. In response to a letter inquiring about the High School from Ranking Member Moran. former Interior Assistant Secretary for Indian Affairs Larry EchoHawk stated:

The Bug O Nay Ge Shig High School shows evidence of continuing deterioration . . . Due to the type of construction of the Bug O Nay Ge Shig High School, improvements to the school such as expansion or construction of one building for classrooms or administrative space is not an optimum solution. Preliminary evaluations indicate that

and our communities deserve better than this.

The BIA estimates that the cost to replace the High School facility is approximately \$25 million, which includes a 42% BIA administrative cost of \$7.4 million. Our Band is well aware that all Americans are being asked to make sacrifices in these tight fiscal times, and we acknowledge the difficult funding decisions that this Subcommittee faces. However, the long overdue replacement of this dangerous building is a small price to pay for the health, safety, and future of our children. The Leech Lake people have made significant sacrifices in the form of our homelands. We only ask that the United States uphold the obligations that it incurred and, at the very least, the solemn promises made to our children.

#### **Urgent Need to address BIE Construction Backlog**

The discussion of the construction needs of Indian schools has been ongoing for more than a decade. For many years, the BIA had consistently informed us that they had no money for school construction and to talk to OMB. OMB told us that they provided funding to BIA for construction and that BIA was not utilizing the funds effectively. No solutions were proposed. Further, it has been extremely difficult navigating the byzantine BIA bureaucracy and its layers to obtain school construction information.

Now, the Administration seeks to change its policies altogether by eliminating funding to replace school facilities to instead focus solely on facilities repair and improvement. Essentially, the Administration proposes a moratorium on BIE school construction. We are alarmed by this position change of the Administration and gravely concerned that the Office of Management and Budget (OMB), who appears to be dictating this approach, has a clandestine long-term goal to terminate BIE schools despite its trust responsibilities. The Administration has not consulted with tribal governments on this proposed policy change in violation of its own policy requiring government-to-government consultation and Executive Order 13592 captioned "Improving American Indian and Alaska Native Educational Opportunities Conclusion and Strengthening Tribal Colleges and Universities" signed by President Obama on Dec. 2, 2011, at the White House's Tribal Leaders Conference.

Without proper facilities, our children's educational opportunities are compromised. Section 7101 of Title VII of the No Child Left Behind Act (NCLB) states:

It is the policy of the United States to fulfill the Federal Government's unique and continuing trust relationship with and responsibility to the Indian people for the education of Indian children. The Federal Government will continue to work with . . . Indian tribes . . . toward the goal of ensuring that programs that serve Indian children are of the highest quality and provide for not only the basic elementary and secondary educational needs, but also the unique educational and culturally related academic needs of these children.

The Bug-O-Nay-Ge-Shig Boys Basketball Team completed their season in a March 4th loss to Blackduck in the first round of the section 8 playoffs. The boys finished with many great improvements from the start of the season. There is hope for the future as we lose only one senior Blaze Wakefield. We return many fine players for next season that gained valuable experience and strive for greater accomplishments in the future.

In accordance with its obligation to Indian children, the United States must work with us to seek a solution to ensuring that our children go to school in adequate facilities

The President's FY13 budget request solely for school improvement and repair is \$52.866 million, which is a proposed cut of \$17.960 million from the FY12 enacted level and a cut of \$87.643 million from the FY11 actual level - both of which had included proposed funding for school and facility replacement in addition to school improvement and repair. The FY05 enacted level for Indian school construction was \$263.3 million, the FY06 enacted level was \$208.9 million, the FY07 level was \$204.9 million, the FY08 level was \$142.9 million, the FY09 level was \$128.8 million, the FY10 level was \$113 million, the FY11 level was \$140,509 million, the FY12 level was \$70.826, and, as noted above, the proposed level for FY13 is a dismal \$52.866 million limited to school improvement and repair.

The Administration's failure to request and Congress' failure to appropriate sufficient funding for BIE school construction is unconscionable in light of recent DOI Office of Inspector General reports finding "severe deficiencies" at BIE schools that "have the potential to seriously injure or kill students and faculty and require immediate attention to mitigate the problems." Department of the Interior Office of Inspector General Flash Report, Bureau of Indian Affairs and Bureau of Indian Education: Schools in Need of Immediate Action, C-IN-BIA-0008-2007 (May 2007) (emphasis added). 1/3 of the 183 BIE schools are in poor condition and in significant need of repair or replacement. Of the 4,495 education buildings in the BIA inventory, half are more than 30 years old and more than 20% are older than 50 years. On average, BIA education buildings are 60 years old, while the national average for public schools is 40 years.

Our students deserve the opportunity to attend school in an environment where they can focus on learning first, not their health or safety. The current facility adversely impacts their self-worth, and sends a message to them that their education and their lives are unimportant. We urge the Subcommittee to work with DOI to develop a plan of action to quickly find the funding to address the construction needs at the High School. The federal government had no difficulty in taking our homelands. However, Administration after Administration has found it impossible to meet the related obligation to provide for the education of Leech Lake children.

I again thank the Subcommittee for its commitment to Indian children by holding this oversight hearing. It's my hope that the renewed spotlight on Indian education will bring about solutions to the significant problems facing our children and children throughout Indian country.

## **MN Delegation Votes Yes** on Violence Against Women Act, **Bachman Votes No**

A fter the House of Representatives presented a Bill that failed to pass earlier in A the month, a different more comprehensive effort passed both Houses and was sent to President Obama's desk. The previous Bill that was presented did not provide for as many protections as the new effort. Most importantly, this version goes further by offering broader protections for victims of domestic abuse, as well as allowing American Indian women to take their case to tribal courts even if their assailants are non-Indian, which -until now- have not had jurisdiction over assailants who do not live on tribal land. The previously failed House bill offered a similar provision, but also maintained that non-Indian defendants could take their case to a federal court.

The entire Minnesota Congressional Delegation voted to support the Violence Against Women Act except for Michele Bachmann. The Sixth District's Congressional Representative Voted against the Bill that not only helps protects women and the GLBT community against violent abuse, but it also broadens Tribal Court's jurisdiction when it comes to protecting American Indian Women that are victims of abuse at the hands of non-indians. Bachmann spokesman Dan Kotman said in an interview with the Star Tribune, "Rep. Bachmann recognizes the importance of giving local law enforcement and nonprofit programs the resources they need to fight against domestic violence and sexual assault, which is why she supported the stronger House version of the Violence Against Women Act."

The new tribal jurisdiction provisions in VAWA give authority to Tribal Governments to prosecute non-Indian defendants that are in relationships with Native women and who assault these victims within the boundries of the reservation. Current laws do not authorize Tribal law enforcement or Tribal Courts to address any form of charges or justice against these perpetrators.







## **Interview with Fred Isham CTAS Application 2013** Thursday, February 28, 2013

On a cold February morning, I had set out to gather some information for our grant application to the Coordinated Tribal Assistance Solicitation, a funding source we apply for annually to supplement our Tribal courts, domestic violence assistance, child welfare and police funding. I was given the name of someone who is currently undergoing rehabilitation in the DWI Wellness Court. When I asked him for the interview, he was very happy to share his story with



me. He is a White Earth enrollee in his late thirties and proceeded to tell me about his personal and spiritual growth he has encountered as a result of this program. He said his journey, however, actually began some 14 years ago when there were things happening directing him towards a better life. This began with him being awakened people speak the language fluently, and of those that do, he became alarmed when he in the middle of the night by four crows. It was happening frequently and he found out later that the crows are symbolic in our culture as a messenger yelling at you to come back to sacred earth. Then he began having dreams about the water drum. Once he got his Indian name and began on the right path, he was told that he was supposed to go to the first degree Midewiiwin, but he felt ashamed because of his past drinking and using. When he began Wellness Court, he decided it was time to pursue and his family. the Midewiiwin lifestyle and teachings.

1. Tell me in what capacity you became involved in the court system?

He got his second DUI and was on probation for the first one, so it was a probation violation. Typically, for a probation violation, one has to sit 30 days in jail. The night before he was to see the judge he praved to the creator. When he went before the judge, he was asked if he was an alcoholic. He replied, "yes", and then was asked if he wanted to get help. He said "yes" and was given the option of Wellness Court and was released the next day. To him, it was a sign that he could live his life 6. With more funding for the Wellness court, what are your ideas on how services better.

2. What crime did you get convicted of? What was the outcome?

He got his second DUI in ten years and was offered 18 months of Wellness Court for gross misdemeanor DUI. Felony DUI offenders generally get offered 2 years of Wellness Court. The court seemed caring and believes that people can change. So far he has seen over 10 people graduate from Wellness Court since he has been in the program.

3. Were you sentenced to treatment?

Yes, outpatient.

- a. If so, what the was length? He did it 3 times a week and finished his time within a couple months.
- b. Have you been in treatment before? He did outpatient in the past but did not complete it because he got a job offer and his probation officer allowed him to quit the program to work.
- c. What about the treatment did you find effective? Being in treatment at Leech Lake has been very effective since they take a cultural approach, rather than a clinical approach. Being introduced to cultural and traditions was helpful in his sobriety as well as spiritually.

d. What support system was provided? As part of his agreement, he goes to court every two weeks. He needs to attend support groups four times during those two weeks. Up to 2 times he can attend ceremonies instead of typical AA support groups, which he finds very beneficial. He submits to regular UAs, but notes they were more frequent in the beginning of his program, when he was more likely to drink. The first six months of sobriety was tough and if it wasn't for the Wellness Court, he would be drinking. With the typical approach of probation it was not very helpful since they wait for you to screw up, then strike you with the consequences. In Wellness Court, the consequences aren't as severe and they are really there to help you be successful. However certain crimes such as driving after revocation could get a person's sentence executed and in his case, could put him in prison. So he is very careful and follows the rules diligently.

#### 4. How has your life changed since you were sentenced?

When he was drinking he was angry a lot and didn't like being cross with people. You can't avoid the way you feel but you can choose how to act on those feelings. Since doing spiritual ceremonies he has been less likely to yell and listens a lot better.

5. What goals do you have for yourself at this point in your life?

The language and culture are rapidly declining here at Leech Lake. Very few heard the statistics that most are elders and will soon be gone. He wants to go back to school to learn and teach Ojibwe. He's worried about us losing the language because along with the language comes culture and identity.

He owns a A-frame house his father built and would like to finish paying it off. He would like to renovate some parts of his home and make it more comfortable for him

He will continue Midewiiwin teachings to help himself and others. It is important for him to contribute to the healing of this community. He has built a sweat lodge in his backyard after having a dream about it. He was told by his mentor that he needed to get a woman's permission to do this since the sweat lodge is symbolic of a mother's womb, and when we go inside we are then able to be reborn. It's a good place to meet with other men and teach each other what the man's role is and how to be respectful towards women.

can be expanded?

"They do a pretty good job," he said, adding "I've seen a lot of good come from it." He is glad the reservation is doing this approach rather than the counties. It needs to be tribally-led to infuse the culture.

#### 7. Do you see things changing in a positive way in the community?

He said he does see some small changes occurring. He sees a lot of people coming into sobriety. "People are starting to wake up and live their lives in a better way". He said a lot of things changed for Natives when they passed the Freedom of Religion Act, but many who grew up in the boarding school era do not feel comfortable talking about the traditions and teachings. He would like to see more value placed on elders. It was very troubling for him one day when he saw an elderly man in a walker carrying his groceries and struggling to make it across a 4 lane highway. "Where was his family?" he asked.

8. Do you know others who have gone through the Wellness Court?

Recently a non-native friend who works at the Palace Casino graduated. He said he seems very happy when he runs into him and not like before when he saw a lot of signs of depression. He also frequently checks the surrounding county jail's

websites and doesn't see people from the Wellness Court in custody, which is a good sign the program is working.

9. Do you have any ideas on how funding could be used to help our juveniles?

be successful. There's a lot of draw to the youth towards gangs since they offer structure and other things that the youth may be missing from their home life. At home, maybe no one gives them nurturing and structure and rules which kids crave. If their mother and/or father do not care for them, gangs will, but in a perverted way." they came from. Part of learning this comes in a rite of way passage where one goes out into the woods and fasts for several days. In his case, he did it later in life and spent 4 days and 4 nights in the wilderness. When the body and spirit goes through fasting, it helps the little boy spirit going into the spirit of a man. He believes this should be offered to youth as it will help them understand more about themselves since it is a physical and spiritual detoxing. Getting their Indian names is important. Some people may feel that the language and culture are dead, but it truly does help a lot of people. A lot of youth stuggle with and long for identity and purpose, and in his own support groups he hears adults wanting the same thing. Programs that implement a cultural healing would be best. "We have ceremonies for everything" he said, noting that it is always important to honor the woman since they are the givers of life. "A lot of women do not understand how important they are; they lose their dignity and self respect if they are drinking and drugging and promiscuous." "There's a lot of healing that needs to occur in our community and getting consumed by the sadness can be detrimental. It's important to take action. In my case, Wellness Court showed me how to find my culture."

The Cass County/Itasca County/ Leech Lake Wellness Courts are collaborations between the Cass County and Itasca County District Courts and the Leech Lake Tribal Court. The first project started in 2005. Cass County at that time was one of the most deadly counties in Minnesota in terms of alcohol related fatalities. The Wellness Court is designed to address the problem of chronic drunken driving offenses by a combination of treatment, testing and court supervision. The Wellness Court is based on a team approach in which the prosecutor, defense attorney, probation, treatment providers and the judges work together to help offenders find solutions for their lives without mood altering chemicals. In order to graduate, participants must have had a lengthy period of sobriety and be approved for graduation by the Wellness Court team. The success of the programs can be measured by the results. During the first two and one half years of the Cass County/Leech Lake program, there was not a single non appearance by a participant for the weekly court hearings. The recidivism rate is only 6.6%, compared to a recidivism rate of more than 60% nationally and in Minnesota. The biggest impact of the Wellness Courts has been on the individual participants who have changed their lives from dangerous criminals into productive, law abiding, taxpaying citizens who have repaired family relationships and improved their community. The following interview represents a current member of the Wellness Court and his journey towards a better life.






