Spring officially begun on March 20, it is also called the Spring Equinox marking the start of the astronomical spring in the Northern Hemisphere. This is the moment when the Sun's rays are directly overhead the equator leading to a relative equal day and night. Daylight will be equal to around twelve hours and extend to longer days moving forward. The rhythm of nature has restarted and with it, increased sunshine, thawing of Mother Earth, and increased activities within communities.

The Chakra of focus this month is the Sacral Chakra, located below the belly button, home to our sexual organs, and our sense of worthiness. "It is associated with the element of water and the vibrant color orange.

> Foods to Support the Sacral Chakra

pring is here and we are enjoying the longer, brighter days and walking on the earth instead of on ice and snow as the birds sing around us. It's time to lighten our diets, lighten our hearts, and enlighten our minds as we celebrate this season of renewal.

The Sacral Chakra is associated

with certain foods, the representative color is orange. These could be: oranges, carrots, mangoes, squash and sweet potatoes, etc. We can add apricots and cantaloupe to this list of foods, all high in Vitamin A and Beta Carotene, though oranges have their own form of Vitamin A (actually referred to as a Provitamin A called Beta Kryptoxanthin, a carotenoid converted to Vitamin A in the body) as well as Vitamin C. Our bodies need vitamin A for healthy eyesight, maintenance of mucus membranes, and vital functions of internal organs around and below the navel, (sacral area) such as the kidneys, bladder and for healthy reproductive organs in both men and women. Along with Vitamin C, Vitamin A helps strengthen our immune system, making us less vulnerable to viruses that may circulate in the cool air of springtime.

Some studies suggest that foods high in Beta Carotenes may also protect us from certain cancers. Keep in mind, however, that it's important to get the recommended amount of both Vitamin A and Beta Carotene, as too much of a good thing can literally be a bad thing: taking too many of these vitamins as supplements in pill form can actually make a person more vulnerable to disorders and disease, particularly of the kidneys and bladder.

It is interesting to note that the sacral chakra, Svahishthana, is intuitively tuned in to our connection to the earth and the sacred within ourselves. Choose some vibrant orange fruits and vegetables to boost your health while celebrating how their sunny color reminds us of the sun in springtime!

### Behavioral Health | Psychiatric Medication Management Team





### **MARCH RECAP**

### FRIDAY, MARCH 7

Leech Lake Reservation Restoration Amendments Act presented to Senate Committee – The Senate Committee on Indian Affairs met 2/5/25 to vote on S.622, the Leech Lake Reservation Restoration Amendments Act of 2025. The bill was ordered to be reported without amendments favorably.

### **RBC Advocacy**

- Secretary/Treasurer Lenny Fineday met with U.S. Senator Tina Smith last Tuesday to discuss critical issues, including the S.622 bill. Fineday emphasized that the bill merely aims to correct the injustice of the federal government's previous illegal land transfer without the tribe's consent.
- Senator Smith voiced strong support for the legislation, reaffirming her commitment to ensuring its passage. Fineday and Smith also discussed the EPA's role in remediating the St. Regis Superfund Site in Cass Lake. In December 2024, the Leech Lake Band received a \$19.9M grant for constructing a new Division of Resource Management facility, and concerns were raised that recent federal executive orders could jeopardize the funding despite it already being appropriated by Congress.

## **RBC BRIEFS · April 2025**

CASS LAKE – The Leech Lake Band of Ojibwe Reservation Business Committee (RBC) holds weekly briefings on Tuesdays, followed by RBC meetings on Thursdays.

All available council members, including scheduled presenters and LLBO division directors, attend RBC briefings. Agenda items are presented for discussion at the Tuesday briefings and then are voted on for passage at the Thursday meeting. Occasionally, due to time constraints, a combination briefing and conference will take place on the same day.

Two meetings were held within the last reporting month, March 1 to March 31. All RBC briefings and meetings are live streamed via Vimeo and are available to view on *leechlakenews.com* under "Videos." Official meeting minutes can also be found on *leechlakenews.com* under "LL Tribal Council" and "Tribal Council Meeting Minutes."

### **BRIEFING/MEETING RECAPS**

- 1. March 4, 2025 A briefing & meeting was held in the RBC Government Chambers.
  - **Brandy Toft, DRM** Presented a contract for PFAS well drilling by HDR. The winning contractors will oversee the PFAS well project for Bug-O-Nay-Ge-Shig. The agreement was approved unanimously.
  - Kyle Applebee, Accounting / Ryan Kingbird MIS Presented a renewal of contract to begin work with OnBase to replace executime and adobe for LLBO Staff. OnBase is a doc management system and is expected to begin implementation in August 2025. The renewal was approved unanimously.
  - **Kyle Applebee, Accounting** Presented the 2025 fiscal year budget. Public budget hearings will be announced soon. The budget was preliminarily approved but is expected to change with coming amendments.
- **2. March 20, 2025** A briefing & meeting was held in the RBC Government Chambers. **Presentations Given:**
- LLTC Board Charter Amendments This is the first of two rounds of amendments to the charter. The amendments have been under review for one year. Two of the amendments include refraining of RBC from day to day operations and a semi-annual meeting to take place.
- Rebecca McConkey-Greene, Tribal Courts Presented an agreement to begin operating the Bamenim Anishinabeg probationary program. Agreement was approved, unanimously.
   Amanda Conklin/Alden Fairbanks, IHS - Presented an update on IHS project updates. First proj-
- Amanda Conklin/Alden Fairbanks, 1HS Presented an update on 1HS project updates. First project was Septic testing for Arsenic in water wells. Mission community center tested above safe levels, while homes in the areas tested okay. Issue has been addressed, and if any homeowners have issues in the future with arsenic levels, can place an application in with public works for this to be fixed. Septics in the Stoney Point area have a 100% failure rate for high arsenic levels, this is believed to be due to closeness with lakes. Onigum area had a 79% failure rate for septics, this was believed to be due to vertical situation/incorrect soils. Sugar point/Battle Point areas both had 90% failure rate also due to vertical situation/incorrect soils. IHS is planning to address these issues with a construction project that would correct sanitation issues in the previously mentioned communities. IHS currently has found a construction firm and is looking for funding. They plan to apply for grant funding in the next grant cycle.
- Lee Turney, Early Childhood Presented a modification on the early childhood budget. The budget currently has additional money from federal funding that was unspent. Early Childhood wants to use the 2.2 million in additional funds to complete a renovation on the current headstart building. Construction would start in fall 2025 and headstart services would move to the Cass Lake Bena middle school during the time. Project was approved unanimously.
- Lee Giffen, Construction Management Presented a construction contract to update the Battle Point community center kitchen to a commercial kitchen. The project contract was approved unanimously.
- Tracy Howg, Homeless Service Program Presented a construction contract with Kraus Anderson to finish the Lyman Losh Community Center remodel. The project contract was approved unanimously. Secretary-Treasurer Leonard Fineday made the program aware that the construction company chosen has a longstanding history of legal issues with Tribes over construction projects.

## **Annual Report to the Indian People**

via LLBO HEALTH DIVISION

As pursuant to Title I, Indian Health Service funds the Health Services through the Annual Funding Agreement, Leech Lake Health shall make an Annual Report to the Indian People in fulfillment of contractual requirements and report will provide and include the programs, functions, services and activities (PFSA) to be performed. This fiscal year has been involved in proactive planning and capacity building. The management of 55 programs, COVID grants and 99 staff.

### **TRIBAL CLINICS**

The health division operates six (6) clinics, locations in Inger, Ball Club, Bena, Onigum, Bemidji and Cass Lake. All Tribal clinics offer primary care healthcare. The clinic providers maintain a long-term medical relationship with patients. The goal is to empower patients, families and communities to take charge of their own health. The health division has a provider at the Ball Club clinic for the past 23 years and this is the busiest clinic. The Onigum clinic is operational and providing medication distributions this year, the Nurse Practitioner is available one day per week until further notice.

### COMMUNITY HEALTH **NURSING/PUBLIC HEALTH** NURSING

The mission is to provide safe nursing care in a professional and culturally sensitive manner to all members of the Leech Lake Reservation who need such services, integrating all aspects of health care resources. Provided services include home health assessments, case management In-home skilled nursing care, medication management, comprehensive wound care, education, immunizations and screening. with the focus on the patient evaluation, prevention of illness, injury or disability and maintenance of health, medication management, wound care and advocating for patient right. Home health also monitors chronic conditions, monitors cognitive and physical decline, assist with recovery from surgery and coordinating services with other healthcare provid-Collaboration with other health programs include other health prevention programs. Home health care is about patients maintaining their health and independence at home. The Home Health Nursing nurses' visits include on a

monthly basis patient case loads of 15 to 28 patients a month.

### **DIABETES RESOURCE CENTER**

(LLDC) specializes in treatment and management of people living with diabetes. The program educates the community on diabetes prevention, clinic appointments offered in Cass Lake, Bemidji, Ball Club, and Onigum. The promotion of positive health behaviors, glycemic goals and hypoglycemia. In addition, obesity and weight management, cardiovascular disease. Also offered is chronic kidney disease information, retinopathy, care for older adults, footcare and children and adolescents. The Diabetes clinic offers diabetes prevention and promoting health in the communities and population.

### **CHR PROGRAM**

A medical transportation service, the monthly average is providing medical transportation to 80-90 clients on a monthly basis, 222 dialysis appointments, 110 medical appointments, medical deliveries, and cancer appointments and with repeat runs for dialysis clients. In improving skills and training, the Community Health Worker (CHW)

course was make available to have all CHR's become CHW's. Currently two CHR's are taking the course. One CHR will be completing the course in 2025. Transportation continues to be a major concern on Leech Lake. Many families require the use of an automobile, thus experiencing many challenges in long distance areas, seeking out medical transportation.

### **EMERGENCY MEDICAL** SERVICES (EMS)

Provides 24 hours per day,365 days per year basic life support ambulance service with advance life support (ALS) variances and in coordination with the 911 emergency system. Services provided are community event medical coverage, certified training center (First Responders), certified training center (First Aid/CPR. Presently, the Leech Lake Ambulance has MNICS WT meetings, LL EMS end of year services and averages 100 calls per month and seek reimbursement of loaded miles being billable. The lack of reimbursement i.e. Medicare/ CMS leaves financial shortfalls in services. Current law does not allow Medicare to reimburse for care provided by EMS services unless the patient is transported to the hospital via ambulance and often times EMS responds to every call, regardless if someone needs a trip to emergency department or not. Overall, the Leech Lake Ambulance service/EMS is short staffed, underpaid and overworked. The saving grace for Leech Lake Ambulance is the IHS Annual Funding Agreement (AFA) Indian Health Service agreement with yearly base amount of funding. The Ambulance program is in dire need of replacement vehicles, the health grant writer is actively seeking funding for vehicle purchases.

### **ENVIRONMENTAL HEALTH AND SERVICES**

Provide environments surveys, institutional environmental health, safe drinking water issues and sampling, i.e. Tribal School (PFAS) water issue, mold inspections, and injury prevention activities. Works closely with BIA, IHS, EPA, counties, and water sampling centers. Installations of smoke detectors to homes on the reservation. This program encompasses non-infrastructure services as related to air pollution prevention, quality air and mitigation. The goal is improved air quality, improved water quality and climate change. The prior Environmental Specialist

resigned his position in June, with the new Specialist coming in October 2024. Presently getting up to speed on numerous policies and procedures and outside agencies and that Environmental health services are available.

### **ADDICTIONS & DEPENDENCY** A&D with the AFA funds were

used to supplement the administra-

tive salaries by the past director,

assistant, operations manager and

budget/grants manager. Also used some of the funding to help support the Assessment Unit. Whether it is called substance use disorder (SUD), chemical Dependency, or addiction and dependency (A&D) disparities can be higher in the American population. This service will be utilizing the term as that our department is titled at Leech Lake. In just a six-month period, 282 Leech Lake relatives sought SUD treatment services Comprehensive Assessment. This is a tool that opens the door to services across the SUD Continuum of care. To help in arresting, interrupting or meeting people where they are in their recovery journey, with Leech Lake's Addiction and Dependencies department consisting of the following programs: Adolescent Out-Patient, Opiate Program, Women's Services, Family Violence Program, Men's Out-Patient, Wiidookodaaiwag Coalition for Opioid Prevention and the Ahn-Ji-Be-Mah-Diz Recovery Center acted as guides in the journey of our relatives, toward a healthier, holistic approach to sobriety. Staff development has been a building a strong, reliable, consistent, dedicated relacentered work Comprehensive Assessments are referred from a centralized location with the A&D department and as a indicated in opening, can see a referral number of 282 in a sixmonth time frame. Within Leech Lake Services, in the last quarter, 347 relatives were served in each of our 7 programs. Programs provide prevention efforts, in-takes, referrals, transportation, cultural resources, including activities and ceremonies, 1-on-1's, group sessions and advocacy. We want all relatives to have success where ever they may be in their recovery. Part of that consideration is Harm Reduction. We are one of the Tribes who has opted to get two Vending machines available within Leech Lake boundaries. It will be available with items for persons to get cost free from a pair of socks to Narcan. ## **All-Native Officiating Crew Makes Historic Debut at MN State Basketball Tournament**

ST. PAUL - The first All Native American 3-man officiating crew debuted March 14 at this year's Minnesota's State High School League Basketball Tournament.

Each year, less than 100 officials are selected to referee at Minnesota's Highest Tournament out of a pool of 2000+ officials. Officials must be evaluated, go through background checks, have the proper certification, and, of course, have proof of experience.

Jonathan James White(Leech Lake Band of Ojibwe), Phillip

Johnson (Leech Lake Band of Ojibwe) and Dan Jourdain (Red Lake Band of Ojibwe) were selected to work as a team.

White and Johnson each put in extensive work to reach the state tournament level of officiating. White has been officiating junior high and mid-level basketball since high school and began certification for the high school level around 2020. Likewise, Johnson was reffing vouth basketball before he was certified to officiate high school hoops in 2017. Jourdain has eight years of experience at the prep level, and before that he was refereeing youth



and adult tournaments around the region, adding another roughly six years to his total experience.

Prior to the formulation of 3 person officiating, there had been several other Native American officials to make it to the State

Tournament. Ray Walker, & Michael Thomas. Other notable Native American officials in Minnesota include; Frank Bowstring (Leech Lake Ojibwe), Darryl Drouillard(Leech Lake Ojibwe) & Leech Lakes District

Representative Kyle Fairbanks (Leech Lake Ojibwe.)

The trio officiated Caledonia's 69-63 win over Sauk Centre in the Class AA girls basketball state tournament consolation bracket semifinals.

- 8. LLBH hired a second full-time Psychiatric Medication Manager Nurse Practitioner, for the first time in history LLBH has two full-time psychiatric mental health practitioners to provide medication manage-

ment to the community.

- **9.** LLBH hired a part-time Adult Rehabilitative Mental Health Services Practitioner.
- 10. LLBH hired second Crisis Response Behavioral Health Specialist and continues to Crisis Services. LLBH hired Trauma-Informed Clinical Team Lead Mental Health Professional. LLBH has been clinically training eight Mental Health Clinical trainees. So far in 2024, six of the eight have completed their training and passed their licensing exams to become independently licensed Mental Health Professionals by their respective Minnesota licensing boards. During a time of national mental health provider shortages, LLBH has been "growing our own" for Leech Lake.

LLBH strives to fulfill its mission statement by providing a holistic service array to better addresses the needs of the whole family, and the whole community. Miigwech for the opportunity to serve Leech Lake!

### **NUTRITION**

With the Annual Funding Agreement (AFA) has limited services and include supplements to the elders and other medically needed individuals. Approximately 15 individuals are served monthly. Other programs offer healthy eating, and disease prevention from diabetes, obesity, weight-loss and other healthy lifestyles.

### **HEALTH MANAGEMENT**

Health Management continues to set and carry out policies, proce-

dures and goals along with the determinations of the health administrative team. The concept is to efficiently manage a variety of medical, nursing, home health, health clinics, health prevention and to enhance the provision of primary care services on the Leech Lake underserved rural communities. The administrative team involves planning, and monitoring of the Tribal care programs and services. We can make a difference in a meaningful impact by improving healthcare operations and systems.

### ASSISTED LIVING (RED CEDAR **ASSISTED LIVING RCAL)**

RCAL is currently in the process of opening soon. Zellner Senior Health Consulting is engaged in the re-open of Red Cedar. The project kicked off with an on-site visit and met weekly for several weeks to review the action plan, next steps and to resolve any outstanding issues. The assisted living provisional license application was submitted to the MN Department of Health on June 14, 2024. The application was reviewed by an assisted living engineering team and returned on June 24, 2024 for issues related to architectural drawings and required Life Safety Codes. In short, a firewall protection in the ceilings will be required throughout the facility. On December 17, 2024, the State examiners reviewed and the State giving Health division the green light to proceed. The application will be resubmitted to MN Department of Health with an anticipated survey and tentative opening dates of 4-5 months. Thirty-three living (33) residents

with most of the resident service costs to be funded through applicable outside resources.

### RBC Advocacy

- Secretary/Treasurer Lenny Fineday met with U.S. Senator Tina Smith last Tuesday to discuss critical issues, including the S.622 bill. Fineday emphasized that the bill merely aims to correct the injustice of the federal government's previous illegal land transfer without the tribe's consent.
- Senator Smith voiced strong support for the legislation, reaffirming her commitment to ensuring its passage. Fineday and Smith also discussed the EPA's role in remediating the St. Regis Superfund Site in Cass Lake. In December 2024, the Leech Lake Band received a \$19.9M grant for constructing a new Division of Resource Management facility, and concerns were raised that recent federal executive orders could jeopardize the funding despite it already being appropriated by Congress.

**District II Satellite Office Now Open** – The District II Satellite Office is officially open as of March 3, 2025, offering a variety of important services to the community. The office will be open on Mondays, Wednesdays, and Fridays.

### FRIDAY, MARCH 14

Bena Land Transfer Bill (HF1587) – The Bena Land Transfer Bill (HF1587), authored by Rep. Stephenson and co-authored by Rep. Bliss, is working its way through the legislative process. The Tribe is

also focusing efforts on getting the bill introduced in the Senate.

The bill aims to appropriate \$250,000 in fiscal year 2026 to condemn and transfer a parcel of state-owned land in Cass County to the Leech Lake Band of Ojibwe. The land, identified as surplus by the Department of Natural Resources, will be transferred for no cost to the Tribe once the condemnation process is completed.

The land, located in Section 27 of Township 145 North, Range 28 West, is no longer needed for natural resource purposes and has been identified as being better managed under Tribal ownership.

Medically Assisted Detox Center – The Band is seeking a \$1.5 million appropriation from the state legislature for the construction of a medically assisted detox center. This facility would be connected to the Ahnjiibimaadiz Recovery Center (ARC), offering culturally competent care and bridging the gap in detox services in Northern Minnesota.

The band itself has committed 1.6 million to the project to begin clearing and demolishing the former palace casino site to prepare it for the new build.

Currently, no formal bill has been drafted for the funds. However, the Tribe is exploring other funding sources such as opioid settlement money and Substance Use Disorder (SUD) grants.

The facility once constructed will have a 16-bed detox facility, with 4 ADA-compliant rooms, and 2 gender-neutral accommodations. The center will be designed to support patients through their recovery with both medical and traditional healing practices.

This facility will prioritize Leech Lake Band members and descendants of enrolled band members but will be open to anyone needing addiction services.

Twin Cities Property Tax Exemption Bill (SF1579 & HF1126) – LLBO Secretary Treasurer Leonard Fineday testified in both the MN Senate and House Taxes Committees March 5th, in support of the Twin Cities Property Tax Exemption Bill. The bill seeks property tax exemption for the Leech Lake Band of Ojibwe Twin Cities Office Building.

The building serves as a hub for government programs, including Child Welfare, Elder Advocates, Tribal Assistance, and more, and hosts community events. The prop-

erty taxes currently account for twothirds of the building's operating costs, which significantly impacts the Band's ability to serve members who live off the reservation.

The services offered by the Leech Lake Band of Ojibwe at the Twin Cities Office are the same as those offered by other governments that benefit from exempt property tax status. As the members of this committee know, one of the unavoidable costs of conducting government business is office space and the property needed for that office space. Tripling the cost for office space reduces the quality and quantity of services that governments are able to provide. In order to expand the government services available to Leech Lake Band members through our Twin Cities Office, it is necessary to limit the cost as much as possible," said Fineday.

The tax exemption would help reduce operational costs and improve service delivery for Band members in the Twin Cities.

IHS Lease Cancelation – Leech Lake Band of Ojibwe Statement on IHS Bemidji Area Office Lease Reports. The Leech Lake Band of Ojibwe is aware of recent reports regarding the cancellation of a lease identified as the "Indian Health Service-Bemidji" located in Bemidji, MN. We have been in communication with IHS leadership to verify the facts surrounding this situation.

Based on information we have received, the reported lease cancellation is not connected to the main IHS Bemidji Area Office but rather to one of their other office locations in Bemidji. We have been assured that IHS leadership is aware of the reports, is actively working on a resolution, and does not anticipate any interruption in healthcare services for Leech Lake Band members as a result of this situation.

The Leech Lake Band of Ojibwe remains committed to ensuring the well-being and access to healthcare services for all our community members. We will continue to monitor this matter closely and provide updates as needed. Leech Lake leadership remains steadfast in its commitment to holding the federal government accountable for its healthcare obligations. We will continue to advocate and lobby to not only protect these vital services but to expand and enhance healthcare resources for Band members now and into the future.

Department of Public Works

Phone Change – The Department of Public Works Division is streamlining its processes. We will be changing the way we handle applications for Community Services, Well & Septic, Sanitation, and Heavy Equipment. We will have one point person for application intake and answering the main phone line. The main extension has been changed and will include all programs in the building.

Court Updates – The Leech Lake Tribal Court is wanting to remind the public of the availability of Legal Kiosks here at the Tribal Justice Center and in 6 outlying communities.

These kiosks are open to the public, they are free to use, there are no eligibility requirements based on income, identity, demographic, or any other factor. While legal aid services may have eligibility criteria, the kiosks themselves are open to all.

Community members can apply for civil legal aid services, access legal resources, print documents (legal related) and even attend a Zoom hearing in any county in Minnesota. They must provide the Zoom ID and passcode and we'd be happy to assist anyone who needs to attend a hearing using these kiosks.

Tribal Development Economic Broadband Update -In December of 2022, The Leech Lake Band of Ojibwe was awarded a National Telecommunications and Information Administration's Tribal Broadband Connectivity Program grant in the amount of \$18.7 million and will enable construction of 153 miles of fiber optic cable to the Leech Lake outlying community centers; then, where permissible, construct a fixed wireless network by constructing a tower to supply broadband (internet) to homes of families who cannot afford the fiber optic service from their local internet service provider. owning the fiber network, the Leech Lake Band of Ojibwe will control its own broadband within its boundaries and better serve their citizen communities. Table 1 displays the fiber, existing and new towers.

In March of 2025, the project began its movement toward delivery of the entire project of fiber and fixed wireless officially with a contract between Leech Lake Band of Ojibwe and Tribal Ready. Tribal Ready is a Native-owned and governed company dedicated to advancing Tribal sovereignty by empowering Native communities with access to broadband funding, strategic planning, essential resources, and, with the Leech Lake Band of Ojibwe specifically, project management consulting.

### Twila Wilson








