#### **VEHICLE ACCIDENT REPORT PRODEDURES**

- 1. Ensure ALL passengers are accounted for and responsive.
- 2. CALL 911 if immediate medical attention is needed.
  - If accident results in personal injury, you must follow LLBO Health & Safety procedures.
- Call Law Enforcement if ambulance is not needed.
- Secure a Police Report.

If Police Report is unavailable request the following information from responding Officer.

- Officer's Department
- Officer's name.
- Officer's badge number
- Incident Report number (ICR) if available

## **NEVER ADMIT FAULT**

- 3. Exchange the following information with the other driver at a safe location off the roadway.
  - Name
  - Address
  - Phone Number
  - Driver's License Number
  - Vehicle Information And License Plate Number
  - Insurance Company and Insurance Policy Number
- 4. Notify Health and Safety, Fleet Management as Soon as Possible

- **5.** If vehicle needs to be towed, contact

  - Out of Leech Lake area, contact local tow company

- **6.** All LLBO vehicle operators involved in a motor vehicle accident **MUST** submit to a Post-Accident drug & Alcohol test.

  - EMS Manager (218) 766-1302 after work hours & Weekends (if unable to reach Employees Human resources)
